If he doesn't make return as required before March 1, he may have to pay a penalty ranging from \$20, to \$1,000, pay a fine or go to jail. So if you don't want to take chances on going to jail, you better call on the income tax man. If you are not sure about being subject to the tax, better ask him and make sure. Whether you see the income tax man or not, you must make return if subject to tax.

Of course, persons resident in other counties may, if they want to, come and see the income tax man, who will be at the county seat on the date above mentioned

Under the acts of Congress of June 3, 1878, and March 3, 1891, residents of the state of Oregon are permitted to take timber free of charge from the vacant, unreserved, nonmineral public lands of the state, not within national forests, for their own uses for building, agricultural, mining or other domestic purposes, but not for barter or sale, under rules and regulations prescribed by the Secretary of Interior. 
