that fought. While there is some trouble going on in the great countries that fought and defeated Germany, far greater trouble and real fighting has been going on between the little countries that were formed by the divisions of land made by President Wilson and the men who met in Paris. Only a few months ago it was said that more than twenty wars were being fought in Europe and very few of them, if any, have stopped since that time. Although it has been more than a year since I with the other soldiers stopped fighting on the fronts in France, men are actually fighting each other with guns and cannon in at least three places. In Russia the troops of the bolsheviks are fighting those who would wipe out this new form of government and the Italians are fighting the Jugo-Slav troops on the shores of the Adriatic sea over who shall control Fiume. The Serbian and Rumanian troops are fighting each other in the Banat, which is located in the central part of what was Hungary before the war, and the Rumanian troops continue to occupy the cities and provinces of Hungary, although it was forbidden at Paris. In addition to these troubles the question of what shall be done with Turkey and Armenia has not been settled.

"But the British and French are not fighting, are they?" asked Jack.

"Well they are not fighting exactly, but they are quarreling over the boundaries of Syria. The British are having trouble with Ireland and more trouble with India. And the Italians, who greeted President Wilson on his visit to Rome as the savior of the world are today denouncing him with the same degree of fury. I remember another thing. The soldiers of our army who were in the big cities of Europe on Armistice Day, 1918, had to be protected by the police of Europe from the people who wanted to rush up and hug them. Today the European police are busy keeping Americans over there from being killed. For that reason the first anniversary of the armistice brings with it more bitterness than peace, more fighting than friendly feeling. So children, do you think after looking back over the past year and seeing the troubles existing everywhere in Europe, that the United States can afford to join a club that would mean sending American troops to fight in all these places?"

"But won't things be better after a while?" asked Ruth.

"How can they be much better over there later on with a peace treaty to go by when the Supreme Council in Paris with war authority can't control the situation? There has been trouble in some part of Europe since the beginning of history. Since the Great War there is a hundred times more. If we were a member of the world club at this minute just think of the American who would be dying in some foreign country for something in which we have no business mixing! The bodies of 111 American soldiers who were killed in northern Russia were landed in New York city just the other day. They were fighting in a country with which the United States was not at war. That one thing should teach us a lesson. Our business is here. Our troubles are here. With all these things in view I know that no United States senator can honestly vote to make this country a member of the world club."
