4Ls HAVE REACHED HIGH STATE OF EFFICIENCY

manager of the large Booth-Kelly interests at Seaside, Oregon, and president of the West Coast Lumbermen's association, in a Portland interview given while the board of directors was in session, said, "The proceedings of the convention of the 4L board of directors demonstrate that the organization has reached a high state of efficiency and stability. The present membership of the organization embraces many of the largest sawmills and logging camps in the northwest, both west and east of the mountains. These affiliated operations have stood firmly for the conference principle, which is the central idea of the 4L through the past four years which have seen lumber prices go up and down with the consequent fluctuation in wages which have followed."

"The treasurer's report," continued Mr. Dixon, "showed that the finances of the organization, which have been a source of difficulty up to this year, on account of the preponderance of exploitation work in the past, are now in a healthy condition, there being a substantial surplus on hand."

"The tranquility which has marked the lumber industry," concluded Mr. Dixon, "of the northwest since the war, in contrast to every other major industry in the United States, it is generally conceded has been due to the work and influence of the 4L; and the present session of the board of directors gives promise of still greater service to the lumber industry of Oregon, Washington and Idaho, to the whole problem of industrial relations, and to the country at large. Many Pacific northwest lumbermen of all ranks count the 4L organization as one of the best general assets of the industry."
