Eugene, Ore., June 22—(To the Editor)—Nearly 2000 years ago Christ gave us the Golden Rule "Do unto others as you would have them do unto you;" also "thou shalt love thy neighbor as thyself." Now Springfield is Eugene's neighbor. The interests of one are the interests of both. You cannot hurt Springfield without hurting Eugene. The S. P. decided long ago to build the car shops at Springfield, which would benefit both cities. Certain interests think they see a shop and locate them in Eugene and bond the city to raise the money to buy the land which is entirely unnecessary as the railroad now owns land in a better location.

Our bonded indebtedness is now large enough without useless increase. Would it not be wrong to covet Springfield's good fortune and try to deprive them of it at heavy expense when by leaving the matter alone we can reap better advantage and benefit of some big interests?

Let us not be deceived. We can receive greater benefit by having these great railroad shops where the railroad company long has resigned to place them. We can save increase of taxes, practically get the benefit just the same and do no wrong to Springfield or anyone else.
