NO INDICTMENTS ARE RETURNED IN COUNTY ENFORCEMENT PROBE

Although the grand jury investigating recent charges of misconduct in county law enforcement returned no indictments, strong criticism of some of the official personnel and methods employed was voiced in a report issued last week-end.

Jess Daniel, prohibition enforcement officer, Gordon Wells, former deputy district attorney and Melvin Turnbull, former deputy sheriff, all resigned, are each criticized for alleged association with women while engaged on official duty.

The report closes with a statement that investigation has proved a large number of rumors and other reports bearing on alleged criminal acts in law enforcement in the county have been greatly exaggerated. It states that "It is hoped that public officials and employes will in the future not make such an investigation necessary."

AUXILIARY TO CONVENE NOV. 7 TO TALK PROGRAM
