**MOVING BAKERY OVEN IS REAL TASK THINKS FRESE**

Moving a large bakery oven is no light task thinks Fred Frese, proprietor of the Springfield Bakery, who has been busy most of the week moving his bakery from the Laxton building to the Parrish property on Main street.

The large oven is built on top of a large sand pit which is walled in with brick. The oven is built up of large flat stones cemented together with asbestos cement and all of this, sand and all, is covered with a sheeting of sheet iron. A dead air space of four inches between the walls of the case and the bricks, is packed with loose asbestos to prevent loss of heat in the oven. The entire oven must be dismantled before moving, being so large that it would be necessary to cut a hole in the wall to get it out of the building in one unit.

**GOVERNOR NORELD SETS FIRE PREVENTION WEEK**

The week of October 5 to 11 has been designated as fire prevention week in a proclamation issued this week by Governor A. W. Norblad.

Last year fire levied a toll of over 473 millions of dollars in the United States and the economic wealth of the state of Oregon suffered to the amount of \$6,808,000.00.

During the five-year period ending December 31, 1929 nearly 50 millions of dollars in property values were

destroyed by fire in this state, not including the annual devastation of our great forest wealth which, in 1929, amounted to over one-half million dollars, says the governor, who adds that statistics show that 50 per cent of this loss is due to preventable causes.

Civic, commercial, fraternal, and patriotic organizations, the churches and the press of the state is called upon by the governor to aid in stamping out this stupendous drain on the existing potential economic wealth of the state.
