NOTICE

WHEREAS in chapter 127, general laws of Oregon, enacted in 1919, it is declared to be the duty of every person, firm, copartnership, company or association, owning, leasing, occupying, possessing or having charge of or dominion over any land, place, building, structure, wharf, pier or dock which is infested with ground squirrels and other noxious rodents in Lane County, Oregon.

Therefore, all of such persons, firms, copartnerships, corporations and companies owning or having dominion over land in said Lane County, Oregon, are hereby required to take steps to exterminate said gray digger ground squirrels (Citellus douglasii) within thirty days from the date of the first publication of this notice. If such steps are not taken, a person or persons appointed by the county court of said Lane County will enter upon said lands and proceed to exterminate said gray digger ground squirrels (Citellus douglasii) and the cost of said extermination will be levied against said lands.
