## MANY ENROLL IN SWIM CLASSES

Special Evening Class for Adults to Start Monday. Registrations Still Open

## RED CROSS MAN DIRECTS WILLAMETTE PARK DONATES USE OF FACILITIES FOR TEN DAY INSTRUCTION PERIOD

One hundred and sixty-three persons had signed up for the free swimming instructions which are being offered to Springfield people this week through the Red Cross under the direction of C. O. Libby, Red Cross Life Saver at the park one mile south of the Pacific highway.

Classes will be conducted daily for ten days for all ages, excepting the adult evening class from seven to eight which will start Monday and continue for one week. Persons interested in taking advantage of this instruction may still sign up for it at the city hall.

There will probably be twenty-five in the two life saving classes, according to Mr. Hatton. The senior group practices from 2:30 to 3:30 each afternoon, and the junior class from 4:30 to 5:30 daily.

A morning class for ladies who are just beginning is being held daily for one half hour beginning at 10:30. This class has an enrollment of 19 at this time.

By far the largest groups are the boys and girls groups between the ages of 7 and 16. The boys who are non-swimmers practice from 1:30 to 2:00, and the beginners from 2:00 to 2:30.

Hours for the girls classes are non-swimmers from 11:00 to 11:30, and beginners from 11:30 to 12:00. Transportation to and from the park for those who have none of their own is being provided by Lum Anderson, police chief.

The Willamette park pool in the Willamette river affords an excellent place for these classes. Pools which have been constructed make swimming safe for even the smallest children. Locker facilities for all those taking swimming lessons are being furnished complimentary by the park management.

## OBSIDIANS PLAN CLIMBS SUNDAY

Public Invited, Experienced Leaders to Be Furnished for Each Mountain Group

An invitation to Springfield people to join in climbing parties which will scale the South and Middle Sister, and the Husband, three snow-clad Cascade peaks Sunday has been extended by members of the club.

Members of the Obsidian group will lead the climbs of each mountain. They sponsor these public climbing parties for all interested people once each summer. Bad snow conditions on the North Sister will make the ascent of that mountain dangerous. An official party will not be taken up that mountain.

People desiring to make either of the three climbs should make reservations with Cliff Stalsberg at McMoran and Washburne in Eugene, or with the leader of each group. Percy Brown will lead the climb of the South Sister. Those taking this trip are to go by way of Bend and Devil's Lake on Century drive where they will camp overnight.

The Middle Sister climb will be led by Bailey Costello. The Saturday night camp for this group will be at Obsidian camp, leaving cars at Frog camp and hiking in five miles.

Dot Dotson will lead the climb of the Husband. This group will leave cars at Frog Camp.

Climbers are advised to take the following equipment: hobbled boots or heavy shoes, alpenstock, snow glasses, wool socks, sleeping bag, or blankets, flashlight, camera, food and a lunch to eat on the mountain, water canteen and compass.

## FORMER COMMISSIONER DIES AT LATHAM HOME

Body Found Along Road After He Had Sought Fresh Air; Heart Attack Cause of Death

Emmett Monroe Sharp, a county commissioner about eight years ago, died suddenly of heart failure late Saturday night after he had left his home to obtain some fresh air in an effort to relieve an illness. His body was found along the highway near his home.

Clarence Simon, county coroner, decided that death was due to heart failure. Mr. Sharp was born in Lane county on April 11, 1870 and had lived his entire life in this county. He was the son of a pioneer minister, Rev. Joseph Sharp, and operated a store and service station at Latham at the time of his death.

He is survived by his widow, Mrs. Hattie Sharp, and a sister, Mrs. W. S. Keyes, of Cottage Grove. Funeral services were held Tuesday afternoon at 2 o'clock from the Mills chapel in Cottage Grove. Rev. Duncan P. Cameron officiated and interment was made in the Masonic cemetery at Cottage Grove.

## KANSAN LOOMS AS LIONS HEAD

Election of Former Director to Presidency of International is Expected

Los Angeles, California, July 21—Election of Charles H. Hatton of Wichita, Kansas, to the presidency of Lions International in the final session of the convention tomorrow seemed assured today. The International convention will close Saturday.

Mr. Hatton is president of the Peoples Finance company of Wichita and holds office in several other large corporations in Wichita. He attended school at Southwestern college and the University of Colorado, afterwards going abroad to study at Sarbonne University in Paris.

As the probable chief executive of the 2650 Lions clubs throughout five continents, Hatton has stated that "Lionism will make no departure at this time from its established policy of making haste slowly in over-seas expansion. However," he continued, "there will be no 'marking time' until economic conditions get better. We look forward confidently to the time when Lionism will be established in every city and town on this continent that desires to build a better citizenship and a better community in which to live."

"It is a question whether any association of any kind has ever equalled the records of the 17,059 activities carried on last year by our 2650 clubs or has exercised an influence which has been so far reaching."

Probably the greatest service Hatton has rendered the Lions Association and the country as well is the outstanding work he has done in promoting the adoption of the "Moral Code for Youth" in most of the school rooms throughout the country. Mr. Hatton was also responsible for the compilation of three text books known as "Studies in Conduct" to be used for supplementary study in connection with the "Moral Codes for Youth."

As manager of the Good Government Club of Wichita, Charles Hatton became one of Wichita's favorite sons by improving local government and promoting civic improvement, while with the Lions Association Hatton became a favorite in 1927 when he was elected a director of the association at the Miami convention. Since that time he has served in all capacities of the official group of the association.

Camp number 2 of the Booth-Kelly lumber company at Wendling began operations again Monday after being closed down since the first of July. Fifty men are employed. The opening is for an indefinite period. The Wendling mill is now operating five days a week on a six hour day basis.

The Western Lumber mill at Westfir also started operations again on Wednesday of this week. They have been down since June 30. Improvements to a dam at the mill pond were made during the time the mill was idle. The regular crew is on the job there and no extra help is needed, it is said.
