

SCHOOL HEADS PONDER PROBLEM

Method of Distribution of High School Funds Causes Speculation in County

SMALLER UNITS TO LOSE

New Budget Meetings Necessary in Some Districts to Increase School Millage

Operations of the schools will continue the same as they are at the time despite the opinion down by Judge Norton of Lane county in which he declared that Wheeler law was unconstitutional. F. B. Flanery, president of the District 19 school board, told their monthly meeting Tuesday evening.

Technically we are now operating under the County High School tuition law, but must wait until we know just what the county court is going to do with tax money now being paid, which was assessed under the Wheeler law. We must await action of the county court in the distribution of these funds before we will know just how Springfield will be affected, he added.

A meeting of directors of the four schools which brought suit against the Wheeler law, Eugene, Cottage Grove, Junction City and Springfield was held in Eugene Monday night. They talked over with Judge Harris, their attorney, the action which will be taken following the appeal from the Norton decision which is being made by the Lane county court.

Under the Wheeler law a millage for high school education was levied on all assessed property in the county, whereas under the County High School Tuition law the levy, whatever it is decided upon, will be made against assessed property only in non-high school districts.

Larger high school districts are expected to greatly benefit from the change in laws, while some of the smaller districts are sure to lose, if not actual cash, then in the form of increased tax millage.

Under the Wheeler law high school districts were reimbursed on a sliding scale ranging from \$60 to \$30 per student for those coming from outside of the district. The County law provides that each school submit a per capita cost for educating students and this figure will be used as the basis of reimbursement. The larger schools will probably receive more money per student for those out of the district and these unorganized high school districts will have to pay the full cost of educating their students.

Operation under the County Fund plan will not be apt to entail any new budget meeting in Springfield. Here the tax will be lower as will be the income, but it is expected that the income from outside districts will be increased. To do this it seems as though it is going to be necessary for some of the smaller districts to hold new budget meetings which will mean more delay in the assessor's office in computing the tax levy for each district. Ben F. Keeney, assessor, Mr. Keeney said that he has already granted several districts permission to present new budgets at a delayed date.

It seems probable that the Springfield district will have to make some new arrangement with the McKenzie high school district at Waltherville in the matter of payments for educating the 30 or more students from that district. The present plan calls for the payment by the district of \$30 per student plus the money received from the Wheeler law fund which averaged \$35. The Springfield district however, remains free under the new law to make whatever arrangement desired with Waltherville as that is a high school district and levies its own tax for high school purposes. The Waltherville area will not receive the \$35 per student to apply on education costs under the County Fund plan and will have to make up this deficit.

COUNTY BUDGET HEARING DEC. 28

Lane Must Raise \$947,661.16 By Taxation During 1933 Says Budget Committee

FAIL TO REACH CUT GOAL

Wheeler Law Creates Unbalanced Millage Between Organized and Other Districts

Members of the Lane county budget board have finally completed the preparation of the budget for 1933 and have called the county budget meeting for the purpose of hearing arguments and fixing the levy Wednesday morning, December 28, 1932 at the courthouse.

A total of \$102,733.74 was withheld from the 1932 budget in preparing this year's document. The total amount to be raised by taxation for the county next year will be \$947,661.16 according to the budget which was advertised Tuesday.

Savings have been effected in each of the departments of the budget. Elimination of the two county agents, salary slashes, and cuts in the health department made possible a reduction of \$66,685 from the figure of the 1932 budget. Drastic cuts in district road work and the use of O. and C. money to build up the general fund has made possible large savings in this division.

Red Cross to Continue

The Red Cross will continue to administer the relief work of the county although final control over the county appropriation will remain in the hands of the county court members.

50% License Cut Endorsed Here

Chamber Wants Reduction Without Additional Gas or Property Taxes

A fifty percent cut in automobile license fees with no additional gasoline tax or property tax on cars was endorsed by the Springfield Chamber of Commerce at last night's meeting. The chamber delegates to the Lane County Chamber of Commerce were instructed to recommend the fifty percent license fee reduction and communicate the chamber's desires to the county legislators.

A fifty percent cut will allow the state to meet its bonded obligations, maintain existing highways and have nearly \$2,000,000 for new work to match federal aid money, the chamber was informed. More drastic cuts might endanger the real property having to stand part of the road bond burden, it was said.
