TREE PLANTING STARTS IN NORTHWEST STATES

Eastern Oregon Forests Included in Forest Service Artificial Planting Program

The largest spring planting program ever undertaken in the north Pacific region is now under way, according to announcement from the regional forester's office, Portland, Oregon. A total of 1,800,000 trees are being planted on 2,830 acres. The work will all be completed by April 15 or sooner, it is said.

Most of the planting is being done by civilian conservation corps crews, although some of the projects are being handled under the national industrial recovery act authorizations.

The Fremont and Ochocho national forests, in eastern Oregon, have projects of 50 acres each, where ponderosa pine seedling are used. All of the trees for these plantings are raised at the forest service nursery located at Wind River, near Carson, Washington.

Artificial planting is done on areas which have been so badly burned that they will not reforest naturally, it is said.

BRAND ASKS REELECTION TO CIRCUIT JUDGESHIP

Marshfield, March 29.—(Special)—Circuit Court Judge James T. Brand today announced himself as a candidate for re-nomination to the office he has had for the past seven years. He sent his filing to the office of the secretary of state last night.

Judge Brand is 47 years old. He has lived in Oregon since 1909 and graduated from Harvard Law school in 1914. He was appointed circuit court judge by Governor Patterson in 1927 and was elected the next year to a full term.

He is now vice-president of the Oregon State Bar association and is a member of the governor's law reform commission.

OREGON NORMAL SCHOOL GETS NATIONAL RATING

Monmouth.—National recognition has just been accorded the Oregon Normal school by being fully accredited by the American Association of Teachers colleges, the highest rating association in the United States for institutions preparing elementary teachers.

"The curriculum shows a substantial core of subject matter in several fields which are of special benefit in providing adequate background for later teaching," the inspection report states.
