J. E. Sutherland of Roseburg was yesterday brought to this city, says the Salem Statesman, by Sheriff A. C. Agee of Douglas county and placed in the penitentiary, having been convicted of manslaughter and sentenced for a two years' term. The sheriff was accompanied by one guard, and on his arrival in this city walked to the prison with his man, thus saving the expense of cabfare. The cost of bringing the prisoner to this city was \$26.55.

Oregon can raise many products that have been neglected in the past. The way to make the state flourish is to raise every product possible. During the past summer Peter Boler, who resides in the Springfield precinct raised several hundred bushels of cantary feed; and he has sold the same in Portland, Salem and Eugene. He received four cents per pound for the seed. It is better than the canary feed raised in California and other States, weighing considerably more in the bushel.—Eugene Guard.

Mrs. J. B. Coney of near Shelburn is lying quite low at present, with a cancer in the throat.

Mr. and Mrs. Chas Warner will go to Albany to-day to spend Xmas with the old folks at home.

Tommy Parker, of Albany, is an applicant for the position of page at the coming session of the legislature.

Marshal Richardson came home from the state university at Eugene, Monday, to spend the holiday vacation.

A. P. Hiron has been engaged to teach the winter term of school at Shelburn, beginning immediately after the holidays.

X. N. Steeves who has just had his second trial for complicity in the murder of Sayre, has been acquitted by a Washington county jury.

W. H. Rockett, night-watchman of the steamboat "Gypsy" was missed from the boat on her last trip up and it is supposed that he was drowned by falling from the boat.

Monday morning a figure representing a man's body was discovered

suspended from a staff of the Oregon agricultural college, and in the place of the weather signals floated a flag bearing, in large letters, the words, "H. B. Miller may know how to run a sawmill, but he cannot run a college." The effigy and flag were quickly torn down, but the news soon spread and all Corvallis engaged in a discussion of the affair. The act was generally condemned.

Last week we gave an account of the freezing of Fisher Logan's feet at the Walker cabin on the desert between Hampton Buttes and Silver Lake. All hopes of saving his feet were given up, and last Friday his parents brought the young man to this city and on Saturday Dr. Belnap, assisted by Dr. Withim, removed a part of the left foot, removing it at the tarso-metatarsal articulation. On further examination it was found necessary to remove the great toe and the one next to it on the right foot.—Prineville Review.

State Senator A. J. Johnson, of Scio, was in the city yesterday on his way to Portland. Senator Johnson is spoken of very favorably for the position of president of the senate at the approaching session of the Oregon legislature. As to his qualifications for this important position there is no question. He is thoroughly posted on parliamentary usages. He has served his native city several years as councilman and mayor, and is president of the Bank of Scio. This will be the second session he has served as senator from Linn county. He is an energetic, capable young man, and would fill the position with honor.—Tuesday's Albany Herald.

Assessor Deakins, of Linn county appeared before the state board of equalization in Salem Monday and explained that 70,000 acres of indemnity railroad lands had been added to the assessment roll, which accounted for the decrease in average valuation per acre. Cattle, though low, the assessor thought near the market value. Judge Flinn, president of the First National bank of Albany, was also before the board. A dividend of about \$16,000, he stated, had been declared by the First National bank, that had also acquired more real estate than was assessed to the stockholders, which would make the assessment on the bank high. He asked for no reduction, but protested against an increase.

The Arrest of a Quack.

For some months an old man by the name of Wm Hyde has been posing in this and other localities as a physician of great ability and able to successfully cope with Disease in her most virulent and to ordinary disciples of Esculapeus incurable form. Indeed it was the incurables that Dr. Hyde most delighted to find for from them under promise of a cure he could collect the largest fee, and who most willingly employed him. They had been told by respectable physicians that their condition was hopeless and medicine could do them no good, further than to allviate pain. When Dr. (?) Hyde came along and promised to cure them sound and well, or perhaps, only to extend their lives a few months or years, they joyfully employed him. Of course, none of the cases above referred to, received any benefit from his treatment, but knowing the frailty of human life, they (the relatives) usually paid Dr. Hyde his bill and buried his patient. Among the several cases he has treated in this locality is Mrs. J. B. Coney of near Shelburn who is suffering with a cancer on the neck, which owing to its close proximity to important veins, etc., can not be operated upon with any degree of safety to the patient, and which fact was probably told Mrs. Coney by every respectable physician whom she consulted. Hyde heard of the case and by some means succeeded in having himself consulted by them. Of course he could effect a cure and to do so placed a fly blister on one of her arms and prescribed and administered morphine to relieve the pain. Of course his method of treatment could do no material good and the fact soon became apparent. By the advice of others, a Miss Galloway swore to a complaint before Justice R. Shelton, charging the aforesaid Hyde with practicing medicine without the necessary legal permit, and a warrant for his arrest was placed in the hands of Deputy Sheriff Munkers. Tuesday Hyde was in this city, when he was arrested and brought before the court. The court required a bail bond of \$150, which was given by G. W. Phillips, till 10 A. M. the following day, when he was surrendered to the sheriff. Later in the day sheriff and prisoner went over to Stayton to obtain money and witnesses.

North Santiam Lumber Interests.

The Western Lumber Co. of Portland, has made arrangements to ship a quantity of lumber from the Enterprise Company's mill up the North Santiam near the Breitenbush, to Portland. It is said also that a logging train will soon commence shipping logs from up the Santiam to Portland over the O. C. & E. and Southern Pacific road via Woodburn. There are large quantities of the very finest timber in the world up the Santiam which can now be bought at very low figure. A number of Eastern lumbermen have recently been looking over that region with a view of buying timber lands. There is a fortune in these timber lands for the owners in the future. At the rate the forests are disappearing, the modern supply of the whole country must come from the Western forest very soon.—Herald.
