The Detroit Freight & Transportation Co., has been incorporated back by the Detroit Lumber Co., Hoover Brothers, S. V. Hall and Smith & Smith with a capital stock of \$50,000, of which \$20,000 has been subscribed. The object is to build a line from Detroit to Salem. It will be about 54 miles long. It is asserted that this is done on account of the increased freight rate on lumber. Orin Judd is president and Frank Perket secretary of the company.

The young man who starts in life to loaf has taken up a proposition that will prove a hard one in the end. It is the hardest job and is the poorest paid business outside of state's prison. It is in a profession that is overcrowded, and yet no one in it need be afraid of his job. No decent fellow on the outside wants it. Those who do can get another like it. There is no competition in the business. It is the easiest trade to get into and the hardest to get out of this side of perdition—Casey (Iowa) Vindicator.

The United States has 262,000 Indians and they are rapidly advancing in civilization. 24,325 Indian children are being educated in schools; 19,809 in government schools, the balance in public and mission schools. In 1908 there were 26,000 Indians, and among government Indians, Indians pushed by Indian courts for petty offenses were 912; 40,000 Indians read; 40,000 speak English; 20,000 have dwellings and 25,351 are church members. The birth rate was 200 over the death rate. But one white man was killed by Indians in 1908. The disciplining of an Indian school is less than that of an ordinary white school. The self-sustaining capacity of the Indian has greatly increased since the Dawes severalty bill, which granted the Indians land in severalty.

When so many otherwise healthy looking lads were rejected last year by the military doctors, who were examining them for military service we all thought the government was getting too particular. But when the fact became known that these lads were rejected on account of weak heart action and undeveloped respiratory power caused by smoking cigarettes we became alarmed and for a time cigarette smoking was under a ban. With the warning of the military doctors, and the always present evil is again in full swing fixing young fellows for a useless and burdensome life. George D. Torrence, superintendent of the Illinois State Reformatory read a paper the other day before the national conference of charities in Cincinnati upon the relationship of cigarettes to crime in which he says that cigarettes are destroying more boys and young men than are the criminals than the saloon. His assertion is amply supported by his own experience and by the experience of several others connected with institutions. In our own reform school every one of the occupants are cigarette smokers.—Corvallis Union.
