A FEW FARM NOTES

One of the best ways of removing lice from hives is to make them do it themselves, by having a lot of dry dirt where they can dust themselves whenever they feel inclined, having first sprinkled the earth with carbolic acid.

The movement of western horses from the ranges to the centers of distribution continues unabated, says the Breeder's Gazette. It is believed that the trade in such range property was never so good as it has been this year.

Strawberries find a market in every village and town. An acre of strawberries will provide more bushels of fruit than will an acre of wheat yield grain, and the labor of growing the strawberries is no more expensive than is necessary for grain. A strawberry patch may be planted either in the fall or spring.

Good cider differs greatly from that made of inferior apples. Instead of using half-rotten apples select those that are perfect in quality. When the cider is running from the press strain it thoroughly. Use lead barrels, first cleaning the lead from the barrel, but should a little adhere to the sides it will be an advantage. Keep the barrel in a cool place and allow no air to enter other than that which forces in during the drawing at the spigot or faucet.
