The county courts of Linn and Marion county met in Albany Friday and the contract for the rebuilding of the Jefferson bridge and for building revetment works at Stayton. The following bids were submitted for building the Jefferson bridge:

### The Pacific Monthly For August.

The August number of the Pacific Monthly is the best number of that magazine ever issued. It has made a new departure in that it has adopted the plan of having many illustrations, the most popular features of magazines nowadays. The articles, too, are of exceptional interest. They combine the local and the world-wide in such a degree as to challenge the interest of all people in this section.

The leading article is a reminiscence sketch of the poets and philosophers who lived in Concord Massachusetts, the middle of the last century. It is by Wallace Irwin and Conant, who has been a resident of Concord, and who writes from personal and familiar knowledge of that historic old town, its history and its famous people. The sketch is profusely illustrated with fine half-tones of the places famous in Revolutionary history, centering in the Concord fight, April 19, 1775.
