Put Tar On Rollers

Corvallis Or., Jan. 5.—(Special)—Joshua Creffield and Charles Brooks the two religious fanatics, who led the Holy Rollers in the recent spasmotic outbreak of religious enthusiasm in which houses, churches, were burned, and cats and dogs destroyed, were taken from their lodgings on the east bank of the Willamette at a late hour Tuesday night, and plastered with tar and feathers.

About 20 men engaged in the affair, and according to the best obtainable accounts, they are all Corvallis citizens, and men of respectability and standing. They were not disguised, and made little or no attempt at secrecy. They crossed the ferry to the Linn County side and surrounded the Holy Roller house, 200 yards beyond the River. With all ways of escape cut off four or five stalwart men approached the front door, which they burst in after a loud knock.

They took the two apostles from among eight or ten other members of the sect in the room, and after recrossing the ferry, conducted them to a bridge north of the Corvallis sawmill, a quarter of a mile north of the city limits, where the tar and feathers were applied.

The clothing was then put back on the shivering apostles, and they were ordered to leave the community and not return, on pain of worse treatment. Both men hastened to obey, and hurried away on a run, going north along the Albany road.

A sensational sequel to the affair was the subsequent return during the night of Creffield to the Holy Roller headquarters, and his marriage in Albany next morning to Miss Maud Hart, one of the leading beauties of the sect, and a young woman of beauty and high character.

Freight Rates to Advance.

Freight rates on the chief commodities shipped from the East will be materially advanced January 15, the advance being made by general agreement among all transcontinental lines. The new rates will affect the entire Pacific coast. The increased rates will be made on shipments from New York and common points from Chicago and common points, from Omaha and Mississippi River points and from the St. Louis territory. In short all shipments will cost about 10 cents more for each 100 pound brought to the Pacific coast.

DECAY OF THE TEETH.

Germs Allowed to Remain in the Mouth and the Use of Sweets.

The discovery was recently announced that decay of teeth, like other forms of decay, is wholly dependent upon the action of microbes, says J. H. K. in Good Health. The germs are always present in the mouth, and when sweet, starchy substances are retained upon the gums or between the teeth, they set up a sort of fermentation, which produces an acid capable of dissolving the enamel. Pure cultures of these microbes have been found capable of producing an acid which rapidly softens teeth exposed to its action. This discovery explains the deleterious effect of candies and other sweets upon the teeth. The teeth of children are often destroyed by the use of sweets before the permanent teeth have fully made their appearance. As a consequence, the second set are defective, and also decay early.

Invalid's Outlet.

A palatable addition to the menu of a convalescent is an "Invalid's outlet." For this take three cutlets from a neck of mutton, trim one very neatly and fix it between the other two, which should be large enough to lap it all around. Fasten the three together with a string or small toothpick skewers, and broil, turning constantly while they are cooking. When cooked take the middle cutlet out and serve with a little potato snow or some spinach, or whatever the doctor will permit. It will be found that this middle cutlet has absorbed all the juice of the other two and is both delicate and extremely nourishing.—N. Y. Post.
