The crime was committed January 25 last, and the young man, when he found that he was expected to live up to his promise, quietly packed his grip, boarded a train of the Woodburn Silverton branch and left for Portland. The Brenner family, realizing that the youth was leaving the county, decided to act promptly, and a warrant was secured and placed in the hands of Chief of Police McClain of this city, who at once notified the Portland Police. Yesterday morning when Galloway arrived in Portland, he was arrested, and Mr. Brenner went to Portland to identify the man. Chief McClain goes down to Portland to bring up the young man to try him for his crime, as efforts are to be made to settle the case by the two young people, and it is urged that such a course would relieve the youth from punishment for his crime and would save the girl from the scandal certain to engulf her. If this cannot be done the youth will be prosecuted for his offense when he is brought here. Galloway was preparing to leave Portland and tried to escape officer who arrested him, and was \$89 when searched at the police station.

Fatal Shooting Affray.

Corvallis, Or., April 24.—Chester Keedy is dead, James Dunn is dead and David A. Osburn is seriously shot, as the result of a pistol duel that took place shortly after midnight this Sunday morning.

Keedy was aged about 18 years and was the son of George B. Keedy head of the printing department at the college. He was shot and instantly killed by sheriff Burnett while resisting arrest.

Osburn's wound is in the neck, the ball having entered the left side of the neck and he probably died under the right shoulder blade.

The trouble began shortly before midnight when Keedy, after leaving a restaurant, fired off his pistol, and ex-sheriff Osburn who is night officer at Corvallis, undertook to arrest him. Keedy was under the influence of liquor and when Osburn approached he drew a gun and ordered Osburn to halt.

There was some parleying and Osburn continued to advance Keedy shot at him.

Sheriff Burnett was sent for and in due time arrived. James Dunn accompanied him and the Sheriff approaching Keedy, took him by the arm and ordered him under arrest. Keedy whipped out a pistol and began to fire. The shot went wide of the mark, and the second, also aimed at the sheriff, took effect in Dunn's abdomen.

Then Burnett fired and Keedy fell with a shot in his head. Dunn fell into the arms of a companion, firing two shots at Keedy as he did so. Burt Turner, aged 22, is in custody as an accessory with Keedy.

Dunn died Tuesday morning.
