The divorce suit of Mayor W. H. Davis against his wife came up for hearing last evening, before Judge William Galloway, in the circuit court. The two reform school boys who recently escaped from that institution and were eagerly sought by all the officers along the line of the Southern Pacific have been recaptured. They were seen near Jefferson yesterday by a couple of small boys who were out with a toy gun playing in the woods. The lads on seeing the escapes from the reform school at once decided upon a bold plan to capture the two and receive the reward of \$10 each paid by the state for the capture of escapes, and with their toy rifles aimed at the runaways the two lads boldly ordered the reform school boys to march ahead of them into town. Thus the runaways were taken to Jefferson, where the youthful captors turned their prizes over to the authorities. Superintendent N. H. Looney, of the school, and an officer came up and took the escapes back to the school, after paying the captors \$10 each for the excellent work done.—Albany Herald.

The following is from the Portland Journal: "As an outcome of the long continued strife existing at the county poor farm, Miss Mary Myers, the superintendent of nursing, resigned her position yesterday and removed her effects from the institution. Dr. Bowles, the house physician, has threatened to resign twice in the last two weeks but has been held at the county hospital through the earnest solicitation of County Judge Webster and County Commissioners Barnes and Lightner. Miss Myers is a sister of Jefferson Myers, president of the Lewis and Clark Fair commission. She has an enviable record in her profession of nurse, and has succeeded in introducing several radical reforms at the county hospital during her incumbency as superintendent of nursing. Mrs. Lucy Morgan, who is highly recommended by the city board of charities, has been chosen her successor. This makes the second resignation as the resident head of the county hospital since J. E. Courtney has been superintendent of the poor farm. Miss E. M. Shepherd occupied the position for more than a year but clashed with Courtney so frequently that she refused to remain at the institution. Miss Myers was appointed head nurse by the county court about nine months ago. She found affairs in a chaotic state and immediately set about instituting reforms, with the approval of Dr. E. P. Geary, the county physician. She clashed with Courtney frequently and several attacks resigned on account of the trouble. Finally Miss Myers informed the county court that she could not succeed in her plans as long as Courtney was allowed to have charge of the hospital as well as the poor farm. The court hesitated and Myers resigned. She was given a two week vacation under pay by the court, but informed the court that she did not intend to return."

Story of a Gold Find.

How a whipped dog brought fortune to a family is related by W. Kramer, now in Portland from the Sucker creek country.

Free gold amounting to \$31,000 had been taken out of the Briggs ledge on Sucker creek up to Thursday last, according to Mr. Kramer, a millman of Grant's Pass. Besides this the ledge has been traced for a distance of 200 feet along the surface of the hillside, and fully \$400,000 is now in sight. The Briggs family is preparing to put up a stamp mill on the property in order to turn the gold into bullion in the shortest possible time.

Mr. Kramer, who knows all the circumstances of the find, says that a young son of David Briggs was out hunting deer and tried to get his dog to take a deer trail. The dog refused to do so, and young Briggs, becoming angry, beat the canine in order to make him do better. While scurrying about the hillside a rusty looking rock was turned over, and on its under side the gold glittered in such a way as to interfere with the dog whipling process instanter. The trail of the deer was also considered of secondary importance, as young Briggs knew that he had thousands of dollars in sight.

"At present the hills around the head of Sucker creek are alive with prospectors," Mr. Kramer said, "and I look for more big discoveries before the summer is over. The region is high up in the Siskiyous, within a few rods of the California line, and prospecting will be a pleasant outing for the hundreds, even should they not succeed in finding anything. "In the old days of mining, 40 years ago, a great deal of gold dust was taken out of Sucker and Alt-house creeks, as well as from Democratic Gulch, by miners who were not looking for ledges. This gold dust, however, came from just such mother lodes as the one found by young Briggs, and there must be several of these yet to uncover."—Evening Telegram.

Some Hunting Rules.

The following rules are given in an exchange for the hunting season: Always carry your gun against your body, the upper part of the stock in the right hand, the left covering the trigger and hammer, and the barrel in the hollow of the left arm.

Beer tracks and pig tracks are almost alike, but the split in the pig's foot prints are wider than those of the deer. A deer being trailed by hounds always makes for high ground.

If you see a wild cat never stand under it.

If you are chased by a wounded bear run along the side of a hill and upward, and he cannot follow. The bear will always drop downward.

If you pitch your camp in a dry creek bed, never sleep under the steep bank which is usual on one side. Animals could jump on you from the ledge. Camp below a drinking pool, not above it, if you are after game.

A rocky country is usually infested with snakes. Where snakes are plentiful loop a hair rope around your camp. The snake will not cross it. No snake likes being tickled in this fashion.

Never let your game hang out over night in the moonlight. The moon's rays poison the meat.

Never eat jack rabbit without carefully examining the meat for water blisters. Never eat jack rabbit at all during the late summer if you can help it.

Never feed your dogs the entrails of your game.

Never lean a loaded gun against a tree trunk, and don't leave your gun unloaded. Hang it up by the strap.

Be careful when you approach a buck deer that has apparently been shot dead. A deer can kick and gore like a mad steer when he is wounded, and he sometimes plays possum.

If you are going to lay for game at night by a drink pool, don't go there by the trail, and take care that you are always to the leeward.

Learn to shoot a rifle by sighting it, but shoot a revolver by feeling, as you throw a stone.

Always cut the throat of game you kill, and let it bleed to death.
