Notice is hereby given that in pursuance of the Act of Congress approved May 10, 1872, Lincoln Mines Company, a corporation duly incorporated and organized under the laws of the state of Oregon, whose postoffice is Albany, in Linn county, Oregon, has made application for a patent for the group of mining claims known as the Albany group of quartz claims, comprising the Abe Lincoln, Morning Star, Evening Star, Mountain King, Mountain Queen, Queen of the Gulch, Bonanza and Murray locations, in the Third or Santiam (unorganized) Mining District, being parts of sections 14 and 23, in township 11 south, range 4 east of the Willamette meridian, in Linn county, Oregon, and described by the official plat, herewith posted, and by the field notes on file, in the office of the register of Oregon City Land District, Oregon, as follows:
