Fire at the Condensery

Just about 1 p. m. Tuesday the fire alarm brought the fire department and the people out instantly. The fire apparatus was soon on its way to the condensery, where the fire was. The roof on the east end of the main building was set afire from sparks from the smokestack of the boiler room, situated some 50 feet from the main building.

The response of the fire department was so prompt, that small damage resulted. The chemical engine was at work within five minutes from the sounding of the alarm, as an auto pulled it to the scene of action at railroad speed. The damage was probably \$50.

Manager Peery thinks the damage is about \$150, as the chemical engine fluid spoiled a tank of sterilized milk. The milk was not included in the above estimate. The damage is fully covered by insurance.
