CENTRALIA SLAYERS GET 25 TO 40 YEARS

Attorney for I. W. W. Declares
Verdict Prejudiced and Not
Fixing Guilt of Any.

Montesano, Wash., April 5—Judge John M. Wilson today sentenced the seven I. W. W. convicted March 13 of second degree murder for the Centralia armistice day massacre, to 25 to 40 years in the penitentiary at Walla Walla. Roberts, the eighth defendant, was imprisoned in the state hospital. Immediately after sentence was pronounced Vandever gave notice that he would appeal the case. He gave three grounds on which he asked a new trial: First, that the verdict was "senseless"; that it decided nothing; that it did not really determine the guilt of the men, and that the verdict was therefore "meaningless".

Second, that there had been grave errors in law during the trial and in the court's instructions.

Third, Harry Sellers, a juror, had perjured himself in order to "sneak onto the jury"; that he bore prejudice against the defendants and an opinion before he was chosen for jury service.

Vandever declared that bringing troops was designed to intimidate the jury and the public considered the verdict a travesty on justice.

The prosecution expressed dissatisfaction with the verdict and that it was unjust because too lenient.

SCIO HYDRO ELECTRIC PLANT

Specifications for Poles—Sealed Bids Wanted

350 Poles—To be of live Douglas fir, cut at the earliest possible date, and peeled, and piled in courses, with good sized spacers between the layers, and on the ground, so that the poles will season as much as possible.

Size—To be 35 feet long, 7-inch top, and not less than 32 inches circumference, 6 feet from butt.

Poles shall be as straight as possible, and in any event shall not curve in more than one plane, and must be uniform, and the total curve when measured on the inner side of curve, from 6 feet above the butt, to the top, shall not exceed 7 inches for the 35 foot poles and 1 inch for each additional 5 feet of pole longer.

Butts to be sawed square and top roofed.

Also, 20 poles, same as above, 40 feet long.

Subject to inspection and acceptance of the City Engineer.

Bids will be received by the City of Scio for part or all of the above poles on or before April 10, 1920, and the City Council reserves the right to reject any and all bids if not satisfactory.

Will Expand Business.

McKnight & Shelton, proprietors of the Sanitary Market, expect to expand their meat business considerably beginning with this month. They are constructing a building at Mehama in which they will conduct a branch meat shop to supply a camp of some 300 men, besides the residents of that town. They have also secured the contract for supplying meat to the boarding camp at Jordan where the employes of the power construction will be boarded. These camps, in addition to caring for country route customers will cause them to rustle for beef animals and to employ two or three extra men.

NEW FREIGHT CAR SERVICE IS PLANNED

Freight Cars to Be Used in
Common and Where the Need
Is Greatest.

San Francisco—For the purpose of working the freight cars of the country as a unit and to the best advantage of shippers, the railroads have voluntarily formed a commission on car service to work in close co-operation with the interstate commerce commission at Washington.

One of the big tasks confronting all roads, says a S. P. official, is to locate and secure their own freight equipment, which is scattered all over the country.

As an example, among the 2,450,000 freight cars pooled by the administration were 35,800 belonging to the Southern Pacific. Approximately two-thirds of these cars are on foreign lines while in their place we have cars from almost every railroad in the country.

We are anxious to get our own rolling stock on the Pacific Coast again so as to effect whatever repairs their heavy use during the last two years has necessitated, and to make them available for the coming crop movements.

The new commission on car service is operating under an agreement to abide by the car service and per diem rules and authorizing the commission to act as their agent in all car service matters.

To discourage laxity in returning equipment to home lines the per diem charge or daily rental for cars on other than their home lines, has been restored and the rate increased from 60 to 90 cents a day.

Start Greens Bridge-Scio Highway.

Monday Engineer Penfield commenced a survey of the Greens bridge-Scio road, setting stakes for grading which will begin within a few days. The county has purchased a new rock crusher which will be set up at Greens bridge and furnish crushed rock for this road which is about 7 miles in length. The court expects that this crusher will produce about 150 cubic yards of rock a day and give employment to three or four men.—Albany Herald.
