Glory be! What's going to happen next? Two boys tried out the speed of their car on Main street and were fined. Now that a beginning has been made to enforce the law, which is violated every day in some manner, why not continue the good work and arrest and fine those who drive without lights, tail light missing, under age, etc.; not to mention violations of city ordinance.

A dispatch from Washington says that the supreme court holds that "revenue agents must have search warrants to invade private homes in hunting for liquor." It is believed that the decision will prevent wide-spread prohibition raids unless the federal government has information sufficient to obtain a warrant.

A town with a broken down public utility company is usually a broken down town, for it takes prosperous and progressive public utility service to meet the requirements of modern business needs.

It is a small county that is not paying from \$300,000 to \$500,000 more taxes this year than last without any visible increase in wealth or population. Just what the recent legislature has done to the taxpayer will not be apparent until next collection day comes around.

Kelly, president of the Anaconda Copper Co., said to a mesting of employes: "The principal objection the employer has to trades unionism comes from the tendency to preach slowing up on the job and the constant claim as skilled work that which is not skilled."


