WEEDON MOSHER IS INSTANTLY KILLED

Seeing Drag Belt Off Pulleys Gives It a Kick and Is Whipped to Pieces

Last Thursday, while standing near the drag belt at the mill of H. L. Goodwin, about six miles east of Scio, Weedon Mosher, aged 71, and who was a newcomer to this section, attempted to kick the belt into place, and in some manner the belt became caught and started to move, thus dragging him into it and whipping him to pieces.

The scene was one of horrible paralyzing upon those who witnessed it, and few there are who can tell just how the accident happened. At first it was reported that the belt was moving and had started to slip off, when he attempted to kick it into position and his foot caught, but later it was learned that the belt had come off the pulley, and noticing it just kicked the edge and in some manner this caused it to take hold again and he was either tripped or the velocity of the belt in starting overbalanced him and dragged him into the belt, horribly mangling his body.

It is hard to conceive just how it happened that anything was left of him but pieces, from the manner in which he met his death. His left leg was entirely torn off, his back was broken, and his body torn in two at the crotch up to the small of his back, thus disemboweling him. It was a most gruesome task for the undertakers, but they performed their work well and to the satisfaction of the son and daughter, who rushed here upon receiving the information through the papers and from the Elks lodge at Vancouver, Wash., of which the elder Mosher was a member.

Little is known here of the man, but that he was a man of sterling quality and manhood, is attested by the fact that just a few days before he met his death, the members of the mill crew at the Goodwin mill gave him a birthday surprise in celebrating the 71st anniversary of his birth, and this was a mark of rare distinction to a practical stranger in our midst. He came here on June 22, 1922, and met his

Community Fair Saturday Was Huge Success

Entries Large and Varied---Prizes Worth While Exhibitors, Well Pleased, Want Show Next Year

When the sun rose last Saturday morning it showed its smiling face upon what was to be a most glorious day for the people of the Forks of the Santiam, when they would vie with each other for the several small prizes offered for the best displays of vegetables, fruits and flowers.

The work of producing this grand display was accomplished in practically 48 hours, for the real notice did not get out to the people until the issue of last week's Tribune carried the news. And the loyalty of the people was attested in the splendid spirit in which they came forward with the best their field and garden produced.

The year has been very dry, the yield small and of a corresponding decrease in the size of the usual products raised here, but that it was good, that it more than met the fondest expectation of the promoters of the fair, goes without saying.

Several of the local merchants and business vied with each other in putting up booths, and they are entitled to much praise for their enterprising spirit in boosting for the Forks of the Santiam. The Jordan Flouring Mill was there with its new brand of flour, "Bender's Snowpeak," and it attracted much attention, the design on the sack being appropriate to the name. Then came the display of the Scio Condensery, which was arranged in

a very pleasing manner so as to show the several brands put up in the local plant. The eye-opener came when it was shown that they can serve the trade with milk from 650 pound barrels down to 4 ounce cans, and under several labels so as to please the most exacting patron.

The booth of the Oregon Life Insurance Co. also attracted considerable attention, as did the stoves of R. M. Cain, who is striving hard to make Scio a good place to trade. Then came the display of J. D. Densmore, who arranged his booth in an attractive manner and to the best advantage for the visitor to see what he had. He constructed some 40 bins, in which was shown the many kinds of seeds and feeds, together with those in sack and package. The booth of the Scio high school was the cooling place for all, for there they sold cold drinks and ice cream, and incidentally boosted the best local high school in the county. The Tribune's booth was novel and of a different type than all others, for it displayed the various kinds of printing done in a small town shop--some of which is equal to the city shops. It created more enthusiasm than all others, for a guessing contest was in progress all day, and which cost the guesser nothing at all. But we must not forget the generosity of the Meadow Shade Dairy--all the ice cold buttermilk you could drink, and it was free. At the noon day dinner, it

also furnished the butter for the multitude, the famous Meadow Shade brand. Mr. Wagner is building up a large and growing trade on this brand and is now having an addition built to the present plant to take care of it.

In all, the Community Club feels very much elated over the splendid showing thus made on such a short notice, and hopes by next year the fair will be bigger and better than ever before in the history of the community. The entries were large, the prizes appropriate and the contestants elated with the success of their undertaking.

The program was short and full of pep, Dr. A. G. Prill acting as chairman. The address of welcome was made by I. V. McAdoo, the speech of the day by Prof. C. C. Ruth, who acted as judge of the exhibits, and who pointed with pride to the splendid showing of the exhibits. A. C. Heyman, county agent, spoke of the value of these exhibits and the effect they had upon a community united in its work for the upbuilding of the same. H. E. Brown, farm editor of the Albany Democrat, spoke of the united efforts of the community and predicted a bigger and better fair next year, saying we had it in us for one. H. Ohling, of Albany, also spoke and urged support of the county fair.

At the conclusion of the program, a short business session of the club

E. Eichinger had made up his mind to contest with the several men from Brownsville and vicinity for the honor of being sheriff of Linn county was most acceptable.

Mr. Eichinger needs no introduction to the citizens of this community, where he is well known and universally liked, but to the people of the county at large, it is well to say that he would come into office unhampered and with no strings attached to him. He is known as a law-abiding citizen, champion of the right of the people, and foe to the wrong doer.

While the time is short for the circulating of petitions so that his name may appear upon the ballot, it is urged that all who believe in him and law-enforcement, who want a man that is four-square, and who will be ready to do the will of the people, to see that he receives the required number of signatures to assure him a place. These petitions are at J. F. Wesely's, the Tribune office, and at N. I. Morrison's for the signing of same.

Ask for these petitions, then sign them and the Forks of the Santiam will have the next sheriff of Linn county.
