Great surprise was manifest in Washington, D. C., the other day when a raid was made on a gambling joint and no congressman or senator was found. Probably this surprise comes because of the reputation our lawmakers have of gambling with their constituents and winning out.

Report says Mayor Thompson, of Chicago, and his ring were defeated in the recent primaries. He held the position longer than any other incumbent, even though he was termed a radical. The income tax law recently passed by the state legislature seems to have many interpretations. Some say it works a hardship on the small salary man, and others say it will keep capital from coming to Oregon and investing. If it works a hardship on the salaried man, then

it is a hardship which the lawmakers have imposed upon him, but if it does not then the law is meritorious and should stand; the keeping of capital from the state will not occur from the income tax law, but is being done by the lethargy the people show in purchasing Oregon made goods. The small salaried men and women of Oregon, as well as all other states, are the ultimate payers of all taxes, no matter what name taxes are collected under. The printer, the grocer, the butcher, and all lines of business, figure their taxes in with their overhead expenses, but the farmer lets the Liverpool markets name his overhead and other expenses, and the jobber takes the cream. Farming will never pay until the farmer learns to organize and name his own price for the products he raises and sells—income tax and no other tax will help to solve the problem—and when organized to stick and help make the organization the success it should be.

Dressmaking Hints

Self-trimmings are the most popular tailored finishes for the season, reports Miss O'Neale, assistant professor of household arts at the Oregon Agricultural college.

Binding, cut on the true bias is one of the simplest and most usable of self-trimmings. This may be used on collars, cuffs, panels and round neck lines. If desired the binding may be of contrasting color. This type of trimming has replaced the old hemstitched edge which was used indiscriminately on all types of material.

Bias trimmings of the same material as the dress are economical and unquestionably good taste. "A clever finish for the neckline is the use of a narrow bias band instead of the time-worn ribbon bow. The ends may be finished with colored beads or left plain."

One way of letting down last summer's skirt is by binding it around the bottom with a bias fold. When finished the binding should be from three-fourths to one inch wide.

Self-covered buttons are popular this season. These may be used down the front of a vest or on the slash of a sleeve. The rule that the space between the buttons should be less than the diameter of the button should be followed, especially in using small ones. Long lines were achieved on one model by applying flat folds of the material from the shoulder to the waistline and putting buttons on the full length of the fold.

Set in pockets always give a tailored finish to a dress. Tailored button holes, such as the bound button holes, may be converted into a pocket. Arrow heads make an appropriate finish for the ends of pockets. Commercial patterns usually give directions for the making of these button holes. The bound button holes may be used as separate decoration.

Narrow string belts are used for all materials. They are especially good for the figure. They may be finished in numerous ways

such as fringe, beads, points, and square ends. Easy way to turn a narrow belt is to fasten a safety pin through one thickness on an end and work the pin through the belt.

Double loops of grosgrain ribbon, silk braid, and linen tape are good tailored finishes. The loops may be buttoned down if desired. These trimmings may be used in the same way as bias edges.

The materials today are so pliable they work up nicely into self-trimmings. The satin-back crepes may be trimmed by using the reverse side of the material. This makes a truly tailored finish.

Materials suggested as suitable for self-trimmings are the taffetas, the satin-back crepes, the soft woolens, the ginghams, cotton crepes, and the linens.

Debt Decreasing

A statement read to the Student Body by the treasurer of the Gymnasium account shows that the bonded indebtedness of the Student Body has been decreased since school began from \$2500 to \$2000 and that cash payments to other accounts outstanding have totaled \$428.51.
