Those who attended the exercises at Providence church Sunday, in the fourth annual meeting commemorating the uplift service rendered to this community and to the state by Elder Joab Powell and his wife, were again greeted by a splendid program and the fellowship of relatives and friends from various parts of the state. This event in regard to family reunions is also becoming popular, and will grow more so as the years come and go.

The program was in the hands of Rev. Henry Albers, pastor of the church, who presided. Rev. D. V. Poling led the song service, and the Rev. Bryant conducted the devotionals. Miss Lenore Powell gave one of her popular readings.

Great interest is being taken in the reunion, and it is expected that between 400 and 500 of the Irvine kin will be present. Mrs. F. T. Thayer, Mrs. Esther Ray and Mrs. Chas. Beard are direct descendants and they and their families expect to attend. Misses Bertha and Mattie Irvine of Lebanon are sisters of the above ladies and will also attend.
