A sport in the shape of a new type  
of corn that bids fair to be of consid-  
erable value is being developed under  
the direction of the crop department  
of the University of Illinois. In the  
type mentioned the ear, instead of be-  
ing in the usual form with solid cob  
and kernels attached, has no cob at  
all in the true sense, the kernels be-  
ing attached to slender stems some-  
what after the fashion of sugar cane.  
The new variety does not produce as  
large a number of kernels as common  
corn, but it is thought that the amount  
can be increased by careful selection,  
when it will be especially valuable for  
feeding purposes, as it will require no  
shelling.

At many state and district fairs this  
year prizes have been offered for the  
most perfect baby boys and girls, the  
judges taking into account the points  
listed by the National Child Welfare  
association. This is a wholesome tend-  
ency, but the writer has an idea that  
more disappointment is felt by moth-
