It is very dry, east of the mountains, and crops are almost an entire failure in the Crooked river country, and times are very dull. Wool is only valued at 10 cents, and wool men are blue.

The Evangelical Conference of Oregon, closed a most pleasant and harmonious session on the 8th of May, in East Portland. Rev. F. W. Parker of Sweet Home Mission, was appointed to the Newberg circuit, much to the regret of his many friends in Linn county. Mr. Parker is a young man of fine promise, and has made a host of friends considering the short time he has been in our midst.

We have received a letter from Rev. C. I. Brown, of Lacamas, W. T. In it he says: "Lacamas has a saw and planing mill whose capital stock is \$50,000, and a paper mill whose capital stock is \$100,000, and that the latter turns out seven tons of paper daily. The people on this coast have in their power to manufacture all, or nearly all that we need or consume, and in the near future we will ship east that which we now bring across the continent."

The pastors of Chicago have addressed the following to the proprietors of the public press in the United States: "The Sabbath is the dividing line between christianity and heathenism. It is the bulwark that shields our christian civilization against anarchy, and every influence that tends to weaken the power of the Sabbath over the public conscience endangers the stability of republican institutions. The business of publishing and selling newspapers on the Sabbath is in open violation of our state laws. We, therefore, respectfully request you to discontinue the publication of newspapers on Sunday."

STATE'S S. CONVENTION.—The Third Annual Convention of the Sunday school workers of Oregon will be held in the First Baptist Church at Albany on Tuesday, Wednesday and Thursday, the 22nd, 23rd, and 24th of May. Though this is a mass Convention and all attending will be entitled to seats, yet, to insure a representation, each school should elect one or more delegates pledged to attend. This Convention will be held in the very heart of the Willamette valley, and at a place that is easily accessible from all points. AN INCENTIVE.—The following from a Portland paper should be an incentive to our hose team to get in and drill for all there is in them. "The Volunteer Firemen's Association of this city have organized a strong team to compete for the prizes offered at the tournament, to be held in Portland next month. At the last meeting of the Exempt association, \$100 was appropriated for the purchase of a trumpet, to be contested for during the tournament. The Volunteers have taken the matter in hand and will endeavor to make it the most successful ever held in Oregon. Committees have been appointed who will canvass the city for subscriptions. About \$3,500 are needed for purses and properly entertaining of guests during the celebration. The Volunteers racing cart is now being built in this city and will be completed in about two weeks.

CRUSHED BY A TRAIN.

A Son of Hon. Lafayette Lane Run Over by a Train at Roseburg.

ROSEBURG, May 15.—A horrible accident occurred at this place as the train was pulling out last night. The train is helped over Rice's hill by an extra engine, and Lafayette Lane, Jr., has been employed as fireman on this engine. Last night an engineer named Jap Walte and Miss Lucy Burnett, daughter of Hon. S. D. Burnett, of Oak Grove, Douglas county were married. Young Lane attended the wedding, and after the wedding drank freely with the other attendants. When the time for the train to start north arrived, the engineer on the "helper" told Lane that he was in no condition to work, to go to bed, and he would be all right in the morning. This Lane refused to do, saying he was going to work. The engineer, however, refused to let him get on the engine, and the train started to pull out, leaving Lane standing on the platform.

He was determined to go, however, and when the emigrant train reached the spot where he was standing, he caught hold of the platform railing, and attempting to swing himself onto the car, but here he was miscalculated, and missing his footing, the momentum of the moving train precipitated him under the fast moving wheels, which passed over both legs, severing them from his body. Just what his condition is could not be learned, but his chances for life were considered very slim.

The injured young man is a son of ex-Congressman Lafayette Lane, is about twenty years of age and is considered a very bright young man. Yet even his brightness does not save him from teaching a great temperance lesson to the masses. He is a cousin of Dr. Harry Lane, superintendent of the asylum.—ALBANY HERALD.

What is the Matter.

We wonder what has become of the W. C. T. U., of Lebanon? If half of what we hear on the streets, is true, there is certainly great need for earnest work. The White Cross department of this heroic and gallant band, commends itself to the honorable consideration of all who love and honor womanhood, especially to all who would maintain purity of life and are opposed to impurity and lewdness.

The following was sent to us for publication, which we insert with pleasure. It was adopted by the state meeting in Eugene City last week.

PLAN OF WORK.

We your committee on Plan of Work submit the following:

1. That in accordance with the plan of organization of our National Union, we continue to urge the organization of Unions by districts and counties.

2. As our Evangelistic Department is the corner stone of W. C. T. work, binding and holding the whole together, we especially urge our Unions to use their best endeavors in making the efforts of those engaged in this work effective, and that the Unions co-operate in placing in the field a reliable Gospel Temperance worker; that we pledge ourselves to take this speaker and do all we can to make the work effective and self supporting.

3. That our local Superintendents of Scientific Temperance Instruction, be vigilant in their efforts to see that directors and teachers do their whole duty in instructing the youth of our State according to law, and that we secure the amendment to this law affixing a penalty for the violation of the same.

4. As it is evident that the friends of the liquor traffic will endeavor to secure the passage of the high license law, at the next session of our legislature, therefore, we recommend that our Unions circulate petitions asking our Legislators to give us Statutory Prohibition.

5. WHEREAS, It is the duty of the White Ribbon women of Oregon, to acquaint themselves with the argument which compels our lenders to work for the franchise, therefore we recommend that the Superintendent of Literature be authorized to correspond with Unions and suggest the best literature on the subject and urge its careful consideration.

6. That we are much gratified with the progress made in the establishment of the Industrial Home in Portland and earnestly recommend our local Unions to devise ways and means for raising funds for its support. Also to carry it in prayer to Him who said, "For ye have the power with you always and whenever ye will, ye may do them good."

7. As Mrs. Andrews of the National Union has selected and published a list of books for the Local Unions, and as our President has suggested that we give special attention to parts of that course, we recommend that during the year our Unions purchase, read and loan the following books: "Hygiene in the Home," "Our Country," "Science of Politics," "Duties of Women" and "Better Not."

8. That we, as house-keepers and home-workers feel the necessity of more hygienic knowledge on the part of the house-keepers, and recommend that these matters be thoroughly discussed at meetings arranged for that purpose. We especially press this subject upon mothers who need special knowledge to enable them to train their daughters in household economy, and dignity labor.
