

LOWER SODA.

(From our regular correspondent.)

To the seekers after health and pleasure, fresh mountain air, a shade beneath the tall, aromatic fir and pine, there is perhaps no place offering greater inducements to the mountain tourist and nimrod than the Soda Springs, situated on the banks of the Santiam river, accessible from Brownsville, Lebanon and other near surrounding points; coming by the way of Crawfordville a pleasantly situated village on the Calapoia river, the traveler proceeds to Sweet Home, 16 miles from Brownsville and one half way to the springs, where accommodations are found at the Independent hotel and also the St. John, under the management of J. J. Davis. Sweet Home is a progressive town, many new buildings being under construction, there being at the present time two general merchandise stores, two hotels, two blacksmith shops, one tannery three saw mills, one grist, one church under construction, religious services also are held on regular Sabbaths at the town hall, a school house and all the accessories that go to make up a flourishing village. The next stopping place for all travelers desiring good accommodation is owned by Elder J. Shea, well known to the general traveling public as a most courteous and accommodating host. At this place noted for its fine fruit, fresh milk and most acceptable fresh vegetable, good accommodations are found for "man and beast," and it is owing to the exertions of the Elder that the County roads is now in such a smooth and excellent condition being free from stumps, the Cayuse bridge is a safe and substantial manner and the last appropriation of \$300 has been used in a most creditable manner, in fact the road is now as smooth and agreeable for travel as any valley road, thanks to the appropriation and well directed exertions of road Sup't. Elder J. Shea: Eleven more miles of pleasant travel through timber bordering the Santiam river, and the Springs are reached, where beneath the grateful shade of the tall firs are seen the many white tents of the campers, luxuriating on pure air, fresh steak, and crisp brown trout that but a few moments previous were lurking in the clear cool depths of the noisy, bubbling ever restless Santiam. For the dispeptic mother nature has in this location proposed a great sanitarium that no patent medicine or drug can equal. During the past year a new spring has been discovered, situated on the north side of the river, and having a remarkable strong volume of medicated water, being considered superior to the other and better known spring of the south side. For those who prefer to board, good accommodations at reasonable prices can be had at the hotel under the management of the present lessee Mr. Westfall, who also has pasturage or stable room for all stock. During the past month the travel to this resort has been very large, and at the present there are a great many campers from all parts of the state.
