Since the first of the month, 31 saloons closed their doors. Of the 350 saloons, 13 are conducted by Chinamen. There are also 11 wholesale liquor houses. The saloons pay a quarterly license of \$100, and the wholesale houses \$50.

The last chance of the Panama gamblers has now gone. The French government and parliament, instead of undertaking the hopeless task of restoring the losses of the investors at ruinous cost to the national treasury, have been forced to lay bare all the rascality which has been going on and to avenge the wrongs of the defrauded creditors. The disclosure will render it utterly impracticable for the French chambers to legislate in the future in behalf of the bankrupt company. The property on the isthmus and all interested in such excavations as have been made will pass into the hands of the Colombian government. Some effort may be made by that government to sell out its rights to some new construction syndicate, but the doom of the enterprise has apparently been sealed. Whatever hopes may remain for the construction of an inter-oceanic canal are grounded upon the Nicaragua project.—N. Y. Tribune.

The Salem Statesman tells the following, probably manufactured for the occasion: "The legislature hasn't been in session long, but the story tellers are getting in their work and there are some good yarns going the rounds. The latest is on Representative Miller, of Linn: A stranger while stopping at the hotel in Lebanon became sick, and in a short time died. He had no friends there and the people didn't even know his name, but his case had elicited no little sympathy and the citizens got together and gave him a fine funeral. Around the grave there were the usual solemn ceremonies and after their conclusion a man, who had taken a prominent part, inquired if any one would like to say something. There was silence for a moment and then Miller stepped forward and said: 'If no one else wants to speak, I would like to say a few words on the tariff.' We suppose the stranger referred to by the Statesman was Benjamin Harrison, whose political death elicited no little sympathy."

Yesterday afternoon while Mrs. Conrad Myer was out calling, Miss Mary Skelly left the house alone for about an hour and a half, seeing that the doors were securely locked before leaving. While she was away some sneak thieves pried open the back window and entered the house, and ransacked it throughout. Gold watches, chains and jewelry belonging to Mr. and Mrs. Myers were taken out and examined but were left upon the bureau. Also the silver ware was displaced but not taken. Two twenty dollar gold pieces, two ten dollar gold pieces and about \$16 in dimes and nickels, belonging to Miss Skelly was taken. Evidently the thieves were watching and saw that the house was left alone, and also that the folks in the adjacent house were away from home, thus giving them a clear field for operations. As yet no clue to the perpetrators has been gained.—Albany Herald.

We clip the following from Tuesday's Oregonian. "William Young, who lives at No. 371 Front street, reported to the police station last night that a ridiculous attempt had been made to hold him up, on Sixteenth and Hoyt streets early in the evening. While passing there he was approached by a roughly-dressed man who commanded him to throw up his hands. Young inquired the cause, and the fellow, thrusting his hand into his hip-pocket, replied: 'I want your money, and get your hands up quick or I'll shoot.' No pistol was in sight, however, and Young informed the footpad that he was 'dead broke.' 'Then I'll take your watch,' was the reply. 'That isn't worth having, for its broken,' said Young. By this time Young saw that the fellow had no pistol and was bluffing; then, laughing at the bad highwayman, remarked as he started off, 'You had better go off and hold up some kid.'"

Parties who have been out on Portland Heights and in the King tract report that there are quite a number of Chinese peasants scattered about in that section, and that they seem to be converging on the city in search of food. One was seen at the head of Park street yesterday. The cold weather has made it difficult to obtain food, and as they have been so long protected by law they have not yet acquired that horror of destructive man while his necessary for their safety. It is now unlawful to kill them, and if people who see them about will feed them, and bad boys will leave them alone, they make their homes in the vicinity of the city and remain there to raise their broods next spring. They are all around the city and it would be a fine thing to have them in the parks and other suitable places. There is no danger of their attacking pedestrians or applying to the city board of charities for assistance.—Oregonian.
