A Day of Accidents.

Monday was an unlucky day for some people, the following mentioned serious accidents all occurring on that day.

Mr. A. E. Pike, the gentlemanly and popular head miller at the Red Crown Mills, went into the basement to throw off a belt. While engaged in this business, he felt his clothing catch upon the head of a bolt in a revolving shaft, and realizing the inevitable result of being wound up was instant death, he braced himself back with his feet and hands and desperately struggled for life. His hands caught against the edge of a beam and the power exerted split open the muscle connecting the thumb and hand, almost tearing the thumb from the hand, lacerating it fearfully making it a very painful wound, and bruising him on other parts of his body. His clothes were torn, almost stripping him, but so tenaciously did he hold on that the power exerted by the winding up of the clothing threw off the main belt, stopping the machinery and thus saving his life.

James Talt, the 16 year old son of Mr. and Mrs. John Talt, while at work in the Woolen Mills accidentally got his right arm caught in the carding machine, drawing it in and tearing the flesh from the arm above the wrist, and tearing the muscles, flesh and tendons loose at the elbow, laying the bone bare but not breaking it, and exposing the main artery without rupturing it.

Mr. Frank Smith, living on the Seio road, this side of the Santiam, while at work on the road, running three horses to a plow, met with a serious accident. A singletree broke, and the horses pulled him by the lines over the plow, striking on some sharp surface, splitting his chin open to the bone.

Mr. Eichman, living in East Albany, while chopping wood on Mr. Peter Reutner's farm, split his left foot open, making a very bad and painful wound. —Albany Herald.

Another Strike.

Of all the strikes that we ever heard of, the preachers' strike beats them all. The following resolutions sent to the State Board by the Salem Ministerial Board explains itself.

SALEM, Or., April 17, '93.

At a called meeting of the Salem Ministerial association this morning the following resolutions were unanimously passed:

Resolved, First—That we respectfully say to the various boards having the oversight of the state asylum for the insane, penitentiary and reform school, that we adhere to our original proposition of requesting the sum of \$5 for each religious service held on Sabbath, and respectfully request their immediate attention to and settlement of the matter.

Resolved, Second—That if the above arrangement is agreed to by the respective boards, it shall be further agreed that the religious services held at the several institutions shall be under the direction of the Salem Ministerial association, and if at any time it should be desirable by any of the superintendents to have some visiting or other minister conduct services, it shall be with the consent of the Ministerial association, or the minister who has charge of the services on the Sabbath in question, and the compensation shall be paid to the regular pastor just the same.

Resolved, Third—That we suspend services at all state institutions until the matter is amicably settled, providing that we except the asylum for the remainder of this month.

Of this association Rev. Wm. Lund is president, and Rev. J. E. Blair, secretary.

"The laborer is worthy of his hire," and if the ministers preach they should be paid, but for the good brethren to demand what they have, especially in resolution No. 2, seems too much, unreasonable and unchristianlike.

First Oregon Newspaper.

A few days ago Capt. J. H. D. Gray, of Astoria, sent to Portland a well-preserved and neatly bound volume of the Oregon Spectator, which was published at Oregon City in 1846. It was the first paper published in Oregon. It is a four column folio printed in mission type, and has a neat typographical appearance. The bound volume is the property of the Gray estate, and has been sent to James T. Gray, of Portland, who has been requested by a number of old-timers to let them see it.

The first number of the Spectator was issued Feb. 5, 1846. Its editor and proprietor was Wm. G. T. Vault. After the first issue it changed hands. H. A. G. Lee became editor, and J. Fleming proprietor. They continued together till July 23, '46, when Mr. Fleming became editor and proprietor.

On Oct. 1, '46, Gov. Geo. L. Curry became editor, and Fleming was proprietor. Oct. 15, '46, N. W. Colwell bought out Mr. Fleming. Crover and Colwell continued at the helm through the volume till Jan. 21, '47. This volume of the Spectator contains a notice of the first number of the Weekly Californian, published at Monterey, Cal., which was the first newspaper published in California.

The Spectator was issued every two weeks. It tells of the "lively" times on the Willamette, with the racers Mogui and Franklin, that ran twice a week from Oregon City to Champoe with a capacity of 15 or 20 passengers.

Another item of unusual interest is that giving the following facts: In 1840 there were in Oregon 36 American settlers, 26 married women, 13 lay Protestant ministers, 13 Methodist (ordained), 1 Presbyterian (ordained), 5 Congregational (ordained), 32 American women and 32 children.—Portland Telegram.

The Ashland Record tells the following: "On May 27th, 1868, James Hards shot and killed his father-in-law, James Arnold, in the old man's cabin in the Big Butte section now known as Rancherie prairie. Hards had been married to Arnold's daughter a few months, but had not got along pleasantly and she had returned to her father. The killing is supposed to have been in reference to a dispute over the ownership of land. Hards was indicted by the grand jury at the time and was finally released on bail. Hards retained the well known Orange Jacobs as his attorney, who advised him to leave the country. About ten years ago the indictment was dismissed. As was recorded by the Record's Eagle Point correspondent Hards returned to that section of the country a few months ago. He claimed the ownership of his land in that section, which is now fenced in by other parties, and proceeded to make trouble for them. David Dunlap was an eye-witness to the killing, which was a cold-blooded murder. He was at Arnold's when Hards came in, murdered the old man, and before Dunlap could get out of harm's way nearly killed him with a fright. The late grand jury again indicted Hards for murder, and Sheriff Pelton has arrested him and now has him in custody in the Jacksonville jail."

Friday afternoon as two men were repairing part of the lower end of the log chute, at Mr. John Leedy's sawmill two and a fourth miles south of Minto, on the North Santiam, a log got away from the men at the upper end of the chute and came tearing down upon them. One of the men jumped for his life, leaping into the creek twenty-five feet below. The other man, W. R. Swink, was unable to get out of the way, and the log struck him, taking off his left leg at the ankle, breaking his nose and giving him other bruises. His wounds are not considered fatal, and he was promptly, tenderly and carefully attended.—Herald.
