Clipped from our Exchanges Throughout the West.
 The teachers' institute for Columbia county will begin at St. Helens July 27.
 Bird Loosly, of Fort Klamath, realized \$60 last month from the milk of 38 cows, sold to the creamery at that place.
 The county court awarded the contract for a bridge across Row river to L. N. Roney for \$935. The bridge will be a 106-foot span.
 J. Rip Van Winkle brought to Grants Pass a rough piece of gold containing \$100, from Fall creek, last week. His 6-year-old boy found it. The chunk was about half white quartz rock.
 W. B. Keen last week bid in that part of the Hall estate known as the W. A. Hanor place, on the Big Ne-tuena river. The place consisted of about 215 acres and the price paid was \$10 an acre.

DEMOCRATIC PLATFORM.
 We, the democrats of the United States, in national convention assembled, do reaffirm our allegiance to those great essential principles of justice and liberty upon which our institutions are founded, and which the democratic party has maintained from Jefferson's time to our own—freedom of speech, freedom of the press, freedom of conscience, the preservation of personal rights, the equality of all citizens before the law, and the faithful observance of constitutional limitations.
 Recognizing that the money question is paramount to all others at this time, we invite attention to the fact that the federal constitution names silver and gold together as the money metals of the United States, and that the first coinage law passed by congress under the constitution made the silver dollar the unit of value and admitted gold to free coinage, at a ratio measured by the silver dollar unit.
 We declare that the act of 1873 demonetizing silver without the knowledge or approval of the American people has resulted in the appreciation of gold and a corresponding fall in the price of commodities produced by the people; a heavy increase in the burden of taxation and of all debts, public and private; the enrichment of the money-lending classes at home and abroad; paralysis of industries and impoverishment of the people.

Fortunately for the man, the bull made only one pass at him, then allowing him to crawl away without further injury.
 An impetuous fraud visited Grant's Pass last week and succeeded in bilking several of the citizens out of small sums. He has a smattering of knowledge concerning the workings of the Masonic, Odd Fellows and Knights of Pythias orders, and it was his plan to solicit aid from the members. To a Mason he represented his name as being Eldridge, to an Odd Fellow as Samuels and to a Knight of Pythias as Howe.
 C. K. Spaulding, of Newberg, who has a contract for rafting 2,000,000 feet of cottonwood logs from the Santiam river to Oregon city for the Willamette Pulp & Paper Company, of that place, last Tuesday, started the drive, and in consequence the Willamette river, at Salem, has been filled with floating logs, many of which are landing on the banks along the river and on the island below the big bridge. The crew prosecuting the work are now encamped at Buena Vista, where the main portion of the logs are.

SKETCH OF BRYAN'S LIFE.
 He is But Four Months Over 36 Years of Age.
 William Jennings Bryan was born in Salem, Marion county, Ill., March 9, 1850, entered public school until 15 years of age, spending his vacations on the farm; in the fall of 1873, entered the Whipple academy at Jacksonville, Ill.; entered Illinois college at Jacksonville, Ill., in 1877, completed a general education and was graduated with the highest honors in 1881; attended Union college of law at Chicago for two years during which time he was connected with the office of ex-Senator Lyman Trumbull. By his practice of his profession at Jacksonville; removed to Lincoln, Neb., October 1, 1887, and became a member of the firm of Talbot & Bryan. He never held an elective office prior to his election to congress. Was elected to the 52d and re-elected to the 53d as a democrat.
 Bryan exceeds but by 16 months the age limitation placed by the constitution upon presidential candidates, it requiring the man must be 35 years of age.
 After his declination to run again for congress from Nebraska, Bryan purchased an interest in the Omaha World-Herald, and has since been considered its editor on financial and political questions.
 Bryan's refusal to run again for congress was on account of his bitter disagreement with President Cleveland on the money question; Bryan issuing a manifesto in which he bitterly arraigned Cleveland and his administration.
 The Democratic Vote for President.
 The official first ballot after corrections on account of absentees and declinations to vote, stood: Bland 233, Boies 86, Matthews 57, McLean 54, Bryan 105, Blackburn 83, Pattison 95, Campbell 2, Russell 3, Penoyer 10, Tillman 17, Hill 1, Stevenson 2, Teller 8, not voting 185.
 The second vote stood: Bland 231, Boies 37, Matthews 34, McLean 53, Bryan 219, Blackburn 27, Pattison 97, Stevenson 9, Hill 1, not voting 162.
 Bland was then withdrawn and Bryan was nominated. Gov. Stone withdrew Bland and asked that Missouri's vote be given to Bryan. It is said on good authority that Ohio's action in breaking to Bryan was in hopes that it would give the nomination for vice-president to John R. McLean, of Ohio. Iowa withdrew Boies and gave her vote to Bryan. The delegations generally changed the vote of their states to Bryan. Arkansas changed to Bryan. Turner of Indiana took the stand to withdraw Matthews and cast the vote of his state for Bryan. Turpie moved that Bryan's nomination be made unanimous. There were various objections on the part of the states that refused to take part in the vote. The chairman declared the vote unanimous, a majority voting for it. The demonstration was renewed, though the participants seemed pretty well exhausted by their previous efforts.
