A USE FOR WHALE MEAT

The Herald man is enough of a sport that he will try almost anything once and, under certain circumstances, he might be persuaded to try a second nip at a doubtful proposition...

Whale meat has been retailing in the municipal fish market at Portland for 10 cents per pound, but when a Heppner meat dealer falls for the game and orders a trial chunk for his trade the fish trust in Portland sticks him up for 17 cents a pound...

This fish trust is the same combination that fixes an exorbitant wholesale price which forces the country dealer to sell the same smelt at three pounds for 25 cents that are being sold to consumers by the Portland municipal fish market at 85 cents for a 50 pound box.

Reverting to the subject of whale meat the Herald would favor the immediate passage of a law under the provisions of which all food profiteers should be interned in some abandoned fish cannery building with a full-grown odor and there fed on a straight diet of whale meat for the duration of the war.

A GOOD TIME TO START

The following "safe and sane" utterance concerning the necessity of beginning now to get ready for world peace for the future is from the editorial department of the Saturday Evening Post:

"A resolution introduced in the Senate last August by Mr. Owen directs the President to invite all Aily and neutral nations to send delegates to a conference for the purpose of discussing a league of nations to maintain peace."

"There was no difficulty in getting representatives of the United States and Aily nations to a conference at Paris for the purpose of discussing war measures. A conference to discuss international organization presents hardly greater difficulties."

"Organizing a regime of international law and order is a big and difficult task—probably the biggest task to which statesmanship has ever addressed itself. Many pregnant details must be considered. Many differences of opinion will develop. Which is all the more reason for making a beginning. It need distract no particle of energy or attention from the prosecution of the war."

"On the main point an overwhelming majority of the people of every country of Europe and America agree—the point that the world must be intelligently safeguarded, by some system of international organization, against a repetition of this calamity. A

few individuals here and there may speak differently; but they represent no considerable body of opinion anywhere in the world. A government or an official that dissents from the main point does not represent the people.

"There must be a preliminary conference sometime to sketch a plan. Such a conference now could agree upon an outline; and an outline, of however general a nature, agreed to by a representative international conference, would be a capital stroke for speedy and acceptable peace. Its influence, within Germany and without, would be important."

"Unrepresentative government pushed the world into this war. Unrepresentative government is not unknown at times even among democracies. Mere governmental indifference has defeated many a good project. All governments will be busy enough directly after the war. The favorable juncture for launching an international organization may slip by—which would be a betrayal of the people of the whole world."

"A start—a definite beginning—is necessary. Public opinion should demand it."

New Idea in Airplane

I. N. Dushane, who was here recently from Carnegie, Pennsylvania visiting his cousin, Judge C. C. Patterson, is interested in a Pittsburg company which is building a new model airplane which promises to work still greater wonders in the air than has thus far been accomplished. The new machine is provided with four lifting propellers which will drive the plane straight up from the ground without the slanting start now necessary. It can be driven vertically to any desired height and dropped down to a landing in the same manner. A driving and reverse propeller will drive the machine in any desired direction when in the air, the same as any ordinary aircraft. The crowning point of efficiency claimed for the new plane, however, is it may be stopped and held absolutely stationary in the air at the will of the operator. This, it is claimed, will make the new machine invaluable for dropping bombs on enemy positions, munition plants, submarines, etc. It can also make flights from or alight upon the decks of vessels at sea without trouble.

Government officials have examined and approved the machine and have already made the company a proposition. Mr. Dushane says, to manufacture the planes on a royalty basis, but the proposition has not been accepted.

When Mr. Dushane left Pittsburg a few weeks ago the engines were being installed and he is expecting a telegram almost any day announcing the result of the trial flight.
