## REAL ESTATE RUMORS

Rumors of realty deals fill the air these days and every live citizen of Heppner is beginning to wish that this pleasant line of talk may soon give place to something more substantial.

Talk is cheap but it takes more than talk to re-build a city that has been as hard hit as Heppner was July 4th. It takes money and initiative and optimism to build a substantial town at any time and during this period of war time high prices it requires a considerable sprinkle of real nerve thrown in for good measure.

But war or no war, high cost of building or low, Heppner must be rebuilt if the town is to even retain the commercial importance she has enjoyed in the past to say nothing of what she should have in the future. If the town is to continue to be a town instead of a country cross-roads, she must have, first of all a modern hotel. That is the town's first and most imperative need. Other buildings are needed to house other business establishments destroyed by the fire but the hotel is of first importance. Four full weeks have passed since the fire and so far as is visible to the naked eye not one move has been made towards building. One actual sale of realty for building purposes has been announced but not a single brick or two by four has been lifted towards a permanent building. Can it be possible that Heppner is not awake yet? Are we going to be like the Arkansas man who had no roof on his home because he couldn't put one on when it rained and didn't need a roof when the weather was dry? If Heppner is to have a hotel or other substantial building before late next year work should be started at once. Only three or four months remain of this year in which outside building operations can be successfully carried on but in that length of time wonders might be worked if the people of Heppner really want their town rebuilt. Right thinking and quick action in the building line are what is needed in Heppner and that is what will pull the good old town out of the rut.

### Our Handicap.

The publisher of the Herald has a splendid newspaper and job printing plant selected in Portland ready for shipment as soon as suitable quarters can be found in Heppner in which to install the office. In the meantime we will be obliged to get along the best we can as we have been doing since the fire and we must ask the forbearance of the public and our patrons and friends until a building can be secured. It is a serious handicap to attempt to print a paper under the conditions now confronting the Herald force and no one knows better than we do that the results are far from satisfactory. Patience and perseverance, however, will overcome all difficulties will be dispelled and some day morning the Herald will again appear from its own plant a bigger and a better local newspaper than it has ever been.

### Will Offer Hotel Stock for Sale.

J. L. Wilkins, manager of the Palace Hotel Co., the physical property of which was recently totally destroyed by fire, authorizes the statement that he will, within a few days, be ready to offer to be

public \$50,000 stock in his company in shares of \$100 each. Mr. Wilkins says he already has customers for a majority of the issue and if the entire amount is subscribed speedily he is ready to guarantee to have work under way on the new building within 30 days.

While details have not been completely worked out Mr. Wilkins expects, if his present plans mature and he is able to carry them out, to erect a 75-room hotel two stories high, of brick construction and which will be strictly modern in design and arrangement. Mr. Wilkins says Heppner is a good hotel town and if his proposition meets with the endorsement and financial support of the business interests of the city he is anxious to remain in Heppner, rebuild, and continue in the business. Otherwise he will probably take hold of one of several other business propositions presented to him since the fire.
