HARNEY NITRATE DEPOSITS TO BE DEVELOPED

A dispatch fro mBend to the Oregonian says: Development work on the nitrate deposits on Sheep mountain and in Stinking lake, both in Harney county, will be started this fall by the Oregon Nitrate company, and to interest eastern capital in the new industry J. H. Morton of this city, president of the company, will leave early in August. Expense will be chiefly at Sheep mountain, 100 miles from Bend as no plant whatever will be required in operating at the lake, 40 miles farther out.

Prospect holes sunk at intervals over the 4800 acre property have shown that the entire mountain is an almost solid mass of nitrate rock assaving high for sodium compounds and from 9 to 23 per cent for potassium salts.

That a fertilizer industry may be built up also at the lake is the belief of officers o the company and with this in view samples of the stratum immediately underlying the deposit of mineral salts have been sent to the Oregon Agricultural College for
