There are perhaps twenty-five or more miles of steam pipes in some of the larger groups of houses. It is imperative that a uniform temperature of 61 to 71 degrees be maintained to secure the best results. The larger structures are 60 feet in width with a length of 400 feet. Many of these originated from grafted stock in the marsh lands of the British lales. The roses are usually made at night so as to reach their destination the following morning. The roses that are particularly tender are gathered while the bud is tight, so as to insure safe shipment.




