

# Delinquent Tax List 1912.

This advertised list of delinquent taxes for the year of 1912 for Morrow County, State of Oregon, is in pursuance of an act of the State Legislature which is embodied in Chapter 301 of the GENERAL LAWS OF THE 1912 SESSION OF THE LEGISLATIVE ASSEMBLY.

The taxes on the following advertised real property became delinquent on the 8th day of April, 1913 and are subject to a penalty of 10 per cent and interest at the rate of 12 per cent per annum until they shall have been paid. Any day after the expiration of six months after the taxes charged against the following real property are delinquent the Sheriff is authorized, upon demand of any person making application, to issue to them a certificate of delinquency upon payment of the taxes, penalty, interest and cost of advertising.

Certificates of delinquency shall bear interest at the rate of 15 per cent per annum from the date of issuance until the certificate is redeemed.
