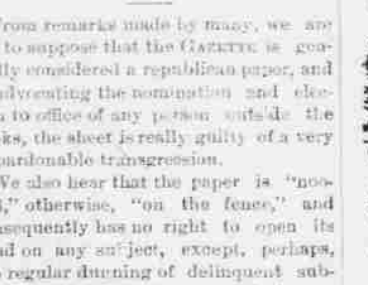
COURT PROCEEDINGS. MONDAY MARCH 26, '90. First National Bank vs R. C. Barclay, dismissed.
