Farmers Needing Cooperative Facilities Can Apply to Rural Rehabilitation Supervisor

Community and cooperative service loans are available for groups of farm families in counties where joint use of coperative facilities such as purebred sires, heavy farm machinery, canning equipment and similar services is more economical than on an individual basis, according to R. S. Thompson, county rehabilitation supervisor, Farm Security administration.

Loans for these cooperative facilities are part of the regular rehabilitation program to bring greater security to farm families unable to secure adequate commercial credit for cooperative enterprises. Two types of loans are available, one on the master-borrower plan for participation of individuals in a community service, and the other for participation in established cooperative associations.
