Registration Stays High at OSC

Oregon State College - Winter term registration at Oregon State college maintained about the same percentage of increase over a year ago as shown in the fall term. At the end of the first week there were between 7 and 8 per cent more students than were enrolled at the corresponding time a year ago, indicating a final registration for the term of around 4350, or just slightly under the record enrollment of last fall More than 100 students have enrolled this term for the first time.

Gasoline sales in Oregon during L. H.
