Farm Price Not Set By Wool Ceiling

Ceiling prices established on wool do not set a maximum farm price, despite the fact that 37.1 cents for greased wool is the basis used in figuring the ceiling price applying only to scoured wool. This explanation has been received by Oregon extension officials from the USDA and OPA headquarters.

While farm prices for wool will naturally bear a relationship to clean wool prices, the price ceiling is on a clean basis and fixes no definite maximum price to the grower.


