Charles H. Mack, Klamath county's active young assessor, has announced his candidacy for the democratic nomination for congress from the second Oregon district on a platform calling for congressional action for war production.

Aged 34, energetic and with a record of nearly eight years of public service already behind him, Mack promises a fighting campaign for the nomination, for which Congressman Walter Pierce, the incumbent, has also filed.

The new candidate was born and reared on a farm in Klamath county, received his schooling in that county and at Oregon State college where he graduated in banking and finance.
