FOR SALE. Sealed bids will be received by the Forest Supervisor, Pendleton, Oregon, up to and not later than 2 P. M. August 9, 1943, for all the live timber marked or designated for cutting and all merchantable dead timber located on an area embracing 40 acres within Section 35, T. 4 S., R. 27 E.W.M., all in the Umatilla National Forest, Oregon, scaled by tree measurement to be 260,760 feet B.M. of ponderosa pine timber and 9,960 feet B.M. of Douglas-fir. No bid of less than \$3.75 per M feet B.M. for ponderosa pine and \$1.75 per M feet B.M. for Douglas-fir will be considered. In addition to the prices bid for stumpage, a cooperative deposit of \$.35 per M feet B.M. to be used by the Forest Service for paying the cost of slash disposal and a cooperative deposit of \$.15 per M feet B.M. to cover the cost of tree planting, seed sowing, and timber stand improvement work on the area cut over for the total cut of timber under the terms of the agreement will be required. \$1230.64 must be deposited with each bid to be applied on the purchase price, slash disposal, stand improvement, and cash deposit in lieu of bond, refunded or retained in part as liquidated damages, according to conditions of sale. The right to reject any and all bids is reserved. Before bids are submitted, full information concerning the timber, the conditions of sale, and the submission of bids should be obtained from the Forest Supervisor, Pendleton, Oregon.
