### ORDINANCE NO. 309

An Ordinance to prohibit chickens, geese, ducks or any other fowls to run at large within the corporate limits of the City of Heppner, Oregon, or to run at large upon the property of others, providing a penalty for the violation thereof and declaring an emergency.

THE PEOPLE OF THE CITY OF HEPPNER DO ORDAIN AS FOLLOWS:

Section 1. It shall be unlawful for any person, firm or corporation to permit or allow any chickens, geese, ducks or any other fowls to run at large upon any street, alley or public property within the corporate limits of the City of Heppner, or go upon or trespass upon any lot or parcel of land of any other person, without the consent of such other person.

Section 2. Any person, firm or corporation violating any of the provisions of this ordinance upon conviction thereof shall be punished by a fine of not less than \$500, or by imprisonment for not less than two days.

Section 3. Whereas chickens and fowls are running at large upon the public streets and alleys within the said City of Heppner and there is no ordinance in effect sufficient to prohibit the same an emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage by the council and approval by the Mayor.
