Smut balls, the specialist points ut, frequently go through the 22-4 City Recorder, Heppner, Ore. treating process intact. Then, when the wheat seed is drilled, the balls break up and are scattered alongside the seed in the drill rows, thus spreading a source of smut infection.

On clean wheat, four methods of seed treatment are being recommended. Ceresan, either in the w slurry form or as the New approved Ceresan dust, gives the st smut control, Warren states. However, copper carbonate and copper sulfate are also recomnded dust treatments for smut.
