The recipe and suggestions for freezing cake are included in expert station circular of information No. 526, "Chocolate Cake for the Freezer." Ingredients, the method of combining ingredients and the oven temperature require special treatment.

The circular also discussed storage of cake batter. Copies of the publication are available from county agents or Oregon State college.
