The theory that milk is a commodity deserving of special treatment is not one peculiar to Oregon whose voters for the third time will pass on state milk control this November. Since 1933, when the legislature passed Oregon's law, 17 states and the federal government have acted to stabilize the marketing of fluid milk in the public interest... This newspaper doubts that Oregon would gain by throwing out a system that on the whole for two decades has supplied the people with good milk at reasonable and comparatively constant prices. The competitive factor, which is the chief attraction of the repeal proposal, could be given freer play within the framework of our present law. We should all see that is done rather than take action which undoubtedly would result in substitution of federal supply for state control over much of Oregon's milk.

The Journal opposes the outright repeal of the milk marketing act, commonly called the milk control law, as proposed by an initiative on the November 2 ballot. It involves too great a gamble with the basic dairy industry and with Oregon's milk supply.
