Penland Publisher Of Livermore News and Herald

Robert Penland, past president of the Oregon Newspaper Publishers Association and former publisher and owner of the Heppner Gazette-Times, became the editor and publisher of the Livermore News and The Livermore Herald on Tuesday, Nov. 1.

He succeeds Lowell E. Jensen whose resignation as publisher is effective on that date. Jensen will remain on the board of directors of the Livermore Valley Publishing Co. and retains an interest in its three publications including the Valley Shopping News-Twin Valleys Advertiser.

M. R. Henry remains as an associate publisher and as a member of the board of directors and retains an interest in the publications; and Arthur L. Henry will be managing editor.

"Mr. Penland has purchased an interest in our publications and has come here to make Livermore his permanent home," Jensen said. "He enjoys an excellent reputation in Oregon as an aggressive and responsible newspaperman. Also, he recognizes the rapid growth evident in Livermore, and enthusiastically endorses the \$100,000 expansion program the News and Herald inaugurated with the purchase of a building and the recent addition of five expensive, new machines to speed up production in the composing room. I commend him to the people of Livermore."

Penland said that he is looking forward to taking a part in the life and activities of Livermore and that plans are being made for the Livermore newspapers to keep pace with the rapid growth of this area, including the rapidly-expanding San Ramon Village.

Mr. and Mrs. Penland have one son, Neal, a high school senior, who remained in Heppner to complete the school year.

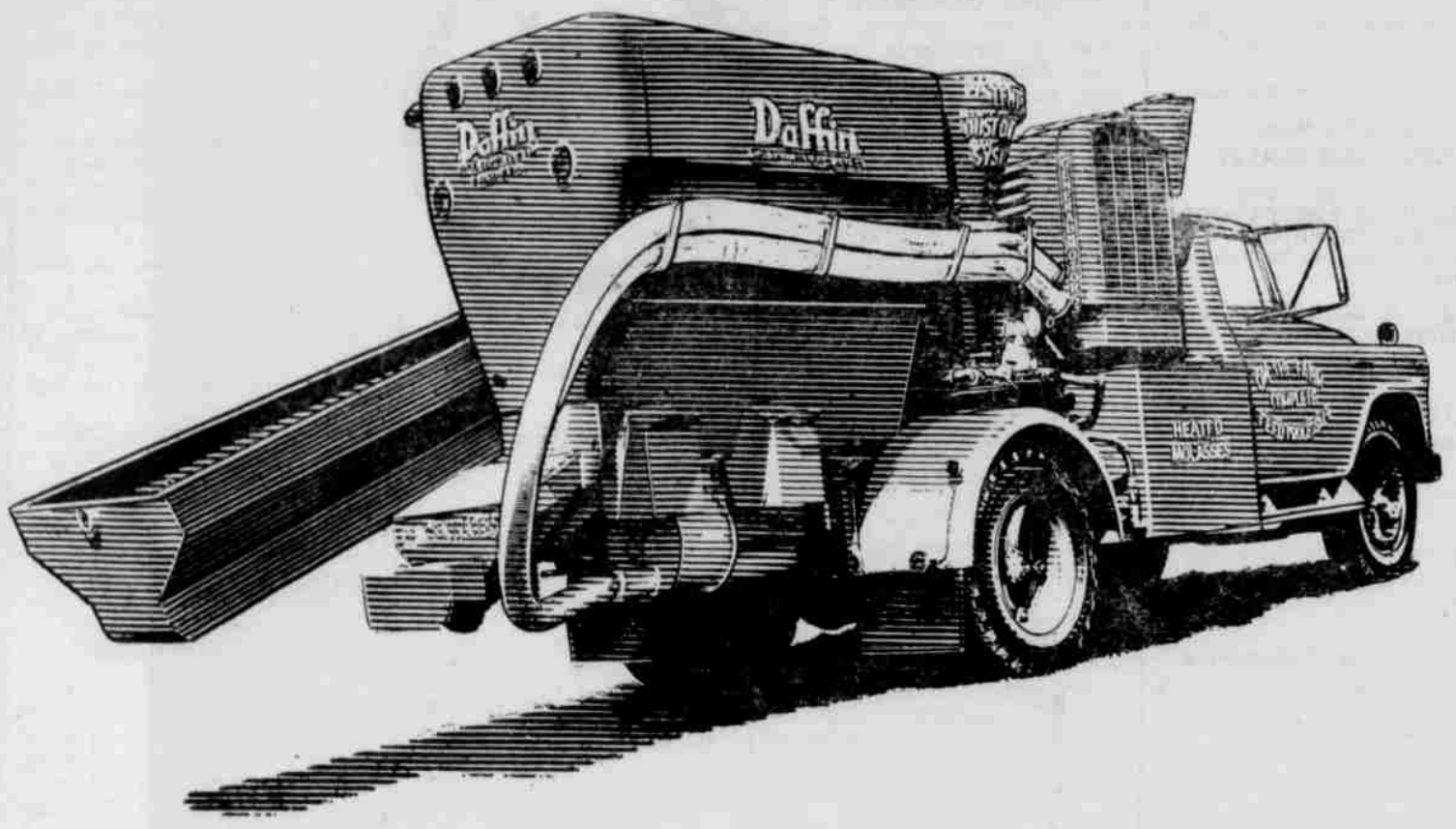
