Big Game Rule Book For 1967 Available

Big game hunters are advised by the Game Commission that copies of the 1967 rule book may now be obtained at license dealers throughout the state.

Hunters accustomed to the large fold-out booklet in vogue for many years will find a radical change in the format of this year's regulations. To make it easier to find specific big game seasons or other information, the format was changed to the regular book form complete with index.

The regulation book does not contain the unit map except in small scale to be used merely as reference. The unit map is printed under separate cover, also available at all license dealers. Hunters should request the Oregon Game Management Unit map when they obtain copies of the regulations booklet. This map, printed in color, contains all unit boundary descriptions.

Hunters should note carefully all general regulations printed in the synopsis, including filing rules and procedures for controlled season tags and permits, arms and ammunition, tagging and possession rules, prohibited methods, and other regulations of this nature.

New Fee Schedule Set on Moorings On Project Waters

A new permit and fee schedule will be put into effect on Federal project waters, effective January 1, 1968, the Chief of Engineers has informed the Walla Walla District.

The new policy will affect permits for private boat moorage facilities on the Columbia and Snake Rivers.

The new permits will replace existing authorizations and will be required for all floating facilities, with a charge of \$10 per year for the first 200 square feet of area, plus an additional 7 1/2 cents per square foot for areas over 200 square feet.

Houseboats, or boathouses with facilities for habitation will be prohibited unless they are self propelled, and then must not be inhabited at permanent mooring points.

Permits for individual floating facilities will be issued only for designated areas away from concentrated park developments. The restrictions against human habitation will apply on all Government-owned land and water areas.

The Walla Walla District of the Corps will issue the new permits within the District and supply application details upon request.

The Corps spokesman said the schedule of fees has been established for Government-owned land underlying moorage facilities to provide consistency with rent being paid by private boat clubs and public marina concessionaires on reservoir projects.

The prohibition on all facilities conducive to human habitation on houseboats, modified boathouses or other floating structures at fixed or permanent moorages is implementation of the long standing Corps' policy of preserving reservoir recreation land and water areas for public use. It is similar to the regulation in most public parks limiting to a few days the period for tent or trailer camping.
