STATE MEASURES

REFERRED TO THE PEOPLE BY THE LEGISLATIVE ASSEMBLY

- 1. EXPANDS VETERANS' HOME-FARM LOAN ELIGIBIL-ITY-Purpose: Amends constitutional provisions relating to eligibility of veterans to receive home and farm loans from the Oregon War Veterans' Fund, YES extending eligibility to any World War II veteran resident in Oregon with at least two years Oregon residence after separation from service before December 31, 1965 (now 1952), and to veterans with service after January 31, 1960, resident in Oregon and with two years' Oregon residence before May 1, 1977.
- 2. DISCIPLINE OF JUDGES-Purpose: Amends constitutional section providing that Supreme Court may remove a judge from office for certain misconduct, by adding authority of Supreme Court to suspend YES or censure as well as remove judge. Present grounds for discipline (felony conviction, failure to perform judicial duties, habitual drunkenness, illegal drug use) are expanded to also include wilful misconduct in office related to performance of judicial duties. general incompetence, and wilful violation of any rule of judicial conduct.
- 3. HOUSING BONDS-Purpose: Authorizes bonds up to one-half of one percent of true cash value of taxable property in state to provide funds for advances to lending institutions and qualified housing sponsors to stimulate the state's economy and provide multifamily housing for the benefit of elderly households, such bonds to be paid from revenues generated by the advances and ad valorem taxes.

ESTIMATE OF FINANCIAL EFFECTS: Based on an estimate of Oregon's 1976 taxable property, this constitutional amendment would establish a maximum bonding limitation of \$185 million to provide additional financing of multifamily housing for the benefit of elderly households.

4. AUTHORIZES VEHICLE TAX MASS TRANSIT USE-Purpose: Amends constitutional provision relating YES to use of motor vehicle fuel taxes and taxes on ownership, operation and use of motor vehicles to permit a tax on ownership, operation and use of motor vehicles levied by a transit district to be used. for transportation of passenaers
