Farmers doing their end-ofthe-year income tax planning and getting ready to prepare their 1980 tax forms, may find the IRS publication, "Farm-

er's Tax Guide," a great help.

"The 'Farmer's Tax Guide' explains how federal tax laws apply to farming," says Manning Becker, Oregon State University Extension farm management specialist. The Farmers Tax Guides are available at the Extension office in Heppner, reports Harold Kerr, County Exten-

The guide gives examples of typical farming situations, and discusses the kinds of income the farmer must report and the different deductions the farmer is allowed. Sample forms and schedules are included in the guide to demonstrate how the various federal tax return forms that the farmer may have to file should be filled
