

### Weed control meeting set

The Morrow County Weed Control District Committee is holding a meeting for landowners with yellow star thistle on Tuesday, April 13, at 7:30 p.m. at the Legion Hall in Lone.

Dave Humphrey, of the Oregon Department of Agriculture, will discuss the cost-share program for the control of yellow star thistle.

Yellow star thistle is an aggressive weed that is currently infesting both sides of Willow Creek north of Cecil. Landowners with this noxious weed in Morrow and Gilliam counties are encouraged to attend.

### 5 Co. residents to chair C.F. events

Five county residents have been appointed chairmen of Cystic Fibrosis (CF) events scheduled in Heppner, Lexington, Lone and Irrigon. It was announced in a recent news release by Charles Dibert, president of the Oregon chapter of the Cystic Fibrosis Foundation.

Calby and Vince Wilson will head up a bike-a-thon in Heppner, Martha Munkers will serve as chairman of a Cystic Fibrosis Fun Day in Lexington, Della Heideman will arrange a bike-a-thon in Lone and the Rev. Richardson has been appointed chairman of a bike-a-thon to be held in Irrigon. The Wilson Bike-A-Thon will be held in September, the news release said and details will be announced at a later date.

One in every 1,800 American children inherits this incurable lung damaging and digestive disease when they receive a gene for Cystic Fibrosis from each of their parents. It is estimated that one out of every 20 Americans is asymptomatic and unknowing carrier of the gene which can cause CF in their child. Through research funded by the Cystic Fibrosis Foundation, a test to identify carriers is being sought and scientists are pursuing a cure or control for CF, the news release said.

Funds raised in the CF events will help support these research programs as well as medical care provided at 128 Cystic Fibrosis Centers located throughout the United States. These CF centers specialize in the diagnosis and care of children with CF. In Oregon, the CF center is located at the Oregon Health Sciences University in Portland.

The events are open to anyone who wishes to help support the fight against Cystic Fibrosis. For more information, contact the area chairmen named above or the Oregon Chapter of the Cystic Fibrosis Foundation, collect at 231-4015, Portland.
